Craig Markley, Office of Systems Planning, reviewed the RISE Local Development application from Mills county to construct approximately 5,650 feet of 190th Street south from Jesup Avenue toward U.S. 34 west of Interstate 29. This project is necessary to provide access to six lots totaling 402 acres for industrial, transportation logistics, and warehousing purposes. Under RISE Local Development criteria this project received a rating of 41 points. Total estimated project cost is \$4,623,712, and the county is requesting a grant of \$1,626,510 and will be providing at least 50 percent in local match. He introduced Kevin Mayberry, Mills County Engineer.

Mr. Mayberry expressed appreciation for the Commission's continuing support and consideration of their application. He introduced Lucas Billesbach, JEO Consulting Group; the design agents for this project. Mr. Mayberry said the change in this project is the addition of a viaduct over the main east/west line for the Burlington Northern and Santa Fe Railroad which will result in the closing of two at-grade crossings in that area. It also will provide the safety feature of keeping the car and train traffic apart.

On behalf of Mills county, Mr. Mayberry expressed appreciation for the Commission's continued support as well as that of the DOT staff.

Mr. Markley reviewed staff's recommendation.

Commissioner Cleaveland moved, Commissioner Rose seconded the Commission, based on the capital investment commitment and potential for future job creation, award a RISE grant of \$1,626,510 or up to 50 percent of the total RISE-eligible project cost, whichever is less, from the county share of the RISE fund. All voted aye.



DISCUSSION/BACKGROUND:						

Lee County submitted a RISE Immediate Opportunity application requesting a grant to assist in reconstruction of approximately 3,270 feet of 180th Street from the new Iowa Fertilizer Co. facility to 360th Avenue, construction of approximately 6,250 feet of 360th Avenue from 180th Street south to Lee County Road J-50, and reconstruction of approximately 12,090 feet of Lee County Road J-50 west to U.S. 61. This project is anticipated to be completed by July 2014.

Because this project will provide improved access to 450 acres for industrial and manufacturing purposes and to maximize RISE support for this project, staff evaluated the application as a RISE Local Development project.

The evaluation and rating for the project will be discussed.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the Commission, based on the capital investment commitment and potential for future job creation, reclassify the project as a RISE Local Development project in the September 2012 round of applications and award a RISE grant of \$4,941,617 or up to 50 percent of the total RISE-eligible project cost, whichever is less, from the county share of the RISE Fund.

Craig Markley, Office of Systems Planning, presented a RISE Immediate Opportunity application from Lee county to reconstruct about 3,270 feet of 180th Street from the new lowa Fertilizer Co. facility to 360th Avenue, construct about 6,250 feet of 360th Avenue from 180th Street south to Lee County Road J-50, and reconstruct approximately 12,090 feet of Lee County Road J-50 west to U.S. 61. This project will provide access to 450 acres for industrial and manufacturing purposes.

Mr. Markley said to maximize RISE support for the project staff evaluated the application as a RISE Local Development project under which the project received a rating of 60 points. The total estimated project cost is \$9,883,233. The county is requesting a RISE grant of \$4,941,617 and will be providing a 50 percent local match. He introduced Mike Norris, Executive Director, Southeast Iowa Regional Planning Commission.

Mr. Norris said it has been a culmination of many months of work to get to this point. He introduced Gary Folluo, Lee County Supervisor; Ernest Steffensmeier, Lee County Engineer; and Jeff Hillegonds, Stanley Consultants. Mr. Norris said at one time this was the largest capital investment in the state's history of \$1.4 billion and 165 jobs. There have been a lot of partnerships with this project, and he expressed appreciation to DOT staff. He said the project will provide safe access to the plant for the 25,000 trucks per year that will be taking product out of the facility on U.S. 61. This project will enable the plant to take advantage of the significant investment the Commission made in the U.S. 61 bypass of Fort Madison. The Highway 61 Coalition is also very happy about that as they endeavor to complete the U.S. 61 corridor. He said they look forward to working with the DOT in implementing the project and having the plant built in the next two to three years.

Mr. Markley reviewed staff's recommendation.

Commissioner Wiley moved, Commissioner Rose seconded the Commission, based on the capital investment commitment and potential for future job creation, reclassify the project as a RISE Local Development project in the September 2012 round of applications and award a RISE grant of \$4,941,617 or up to 50 percent of the total RISE-eligible project cost, whichever is less, from the county share of the RISE fund. Commissioner Reasner abstained; remaining Commissioners voted aye.



Craig Markley, Office of Systems Planning, said the city of Iowa City submitted a RISE Immediate Opportunity application to construct approximately 2,100 feet of Moss Ridge Road and to reconstruct about 2,300 feet of Iowa 1 located north of Interstate 80 on the northeast side of town. This project will provide access to 170 acres for professional office purposes. To maximize RISE support for this project, staff evaluated the application as a RISE Local Development project under which the project received a rating of 41 points. Total estimated project cost is \$3,812,500. The city is requesting a RISE grant of \$1,906,250 and will be providing a 50 percent local match. He introduced Jeff Davidson, Iowa City Planning and Community Development Director.

Mr. Davidson said they appreciate the Department's partnership in economic development in Iowa City. He introduced Mayor Pro Tem Susan Mims and Brett Bosworth, President, R&R Equity Partners. He noted R&R Realty Group is their private sector partner in the development of the Moss Ridge campus office park.

Mayor Pro Tem Mims expressed appreciation to the Commission and Department; these partnerships are absolutely essential in creating high quality jobs in not only their region but the whole state of lowa. They have been working on this project for quite a while and look forward to continuing their partnership with the Commission.

Mr. Davidson said the RISE program has been very successful for them over the years. In the 1990s they had a RISE project for Heinz Road in Iowa City which resulted in locating some prominent firms to their area including Alfa Inc., an European bottling manufacturer that employs 360; United Natural Foods, a natural foods wholesaler that employs 340; Economy Advertising, a promotional products company that employs 100; and Alliance Packaging, a display packaging company that employs about 100. In total, about 900 jobs were created as a result of that investment. Highway one was another RISE project in the 1990s that brought the Mercer Corporation which provides human resources private-benefits services and Pearson, a major academic testing company resulting in some 1,400 employees. They look forward to additional successes.

Mr. Bosworth said the best way to market a project of this size is to have a good location and a good master plan, and they have been working for about 18 months to come up with a great master plan. The Moss Ridge campus has the core fundamentals of location and size to offer companies an office park environment. This is about a 170-acre project which, generally, you are going to build about 10,000 square feet per acre so he thought the area will attract Class A office companies.

Mr. Markley reviewed the recommendation of staff.

Commissioner Reasner moved, Commissioner Rose seconded the Commission, based on the capital investment commitment and potential for future job creation, reclassify the project as a RISE Local Development project in the September 2012 round of applications and award a RISE grant of \$1,906,250 or up to 50 percent of the total RISE-eligible project cost, whichever is less, from the city share of the RISE fund.
