DISCUSSION/BACKGROUND:

The city of Clarion submitted a RISE Immediate Opportunity application requesting a grant to assist in the construction of an approximately 395-foot right-turn lane on Iowa 3 located on the west side of town. This project is anticipated to be completed by December 2013.

The improvements are necessary to provide improved access to Hagie Manufacturing Co., a manufacturer of crop protection and application solutions, and will support:

- The creation of 50 new full-time jobs.
- \$22 million in associated capital investment.

The RISE cost per job assisted will be \$2,545.50, and there will be a total capital investment of \$172.85 for each RISE dollar requested.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the Commission, based on the capital investment and job creation commitments, award a RISE grant of \$127,275 or up to 80 percent of the total RISE-eligible project cost, whichever is less, from the city share of the RISE Fund.

Craig Markley, Office of Systems Planning, reviewed a RISE Immediate Opportunity application from the city of Clarion to assist in the construction of an approximate 395-foot right-turn lane on Iowa 3 on the west side of town. The proposed improvement will provide improved access to Hagie Manufacturing Co., a manufacturer of crop protection and application solutions. The proposed improvements will result in the creation of 50 new full-time jobs within three years along with \$22 million in associated capital investment. Average wage of the created positions is \$14.55 per hour which is 100 percent of the Wright county average labor shed wage rate of \$14.55.

Mr. Markley said the RISE grant recommended is \$127,275. Local participation is 20 percent or \$31,819. The RISE cost per job is \$2,545.50 and total capital investment per RISE dollar is \$172.85. He introduced Shelly Pohlman, Clarion City Administrator.

Ms. Pohlman expressed appreciation for the Commission's consideration of their RISE application. Hagie Manufacturing is a great asset to their community.

Melissa Hagie, Hagie Manufacturing Co., said Hagie is a third-generation, family-owned business. They manufacture agricultural high clearance sprayers, etc. and are excited about this project and look forward to growing the community.

Brad Hicks said Hagie Manufacturing is an important part of the Wright county economy and is a locally-owned, family-owned business; the kind of business that helps rural lowa. He said they appreciate any help they can get to keep those types of companies doing well in rural lowa.

Mr. Markley reviewed staff's recommendation.

Commissioner Reasner moved, Commissioner Rose seconded the Commission, based on the capital investment and job creation commitments, award a RISE grant of \$127,275 or up to 80 percent of the total RISE-eligible project cost, whichever is less, from the city share of the RISE fund. All voted aye.







The city of Ottumwa submitted a RISE Immediate Opportunity application requesting a grant to assist in construction of a right-turn lane on U.S. 34 and reconstruction of approximately 2,500 feet of Iowa Avenue from U.S. 34 north to Kay Avenue located on the east side of town. This project is anticipated to be completed by August 2014.

The improvements are necessary to provide improved access to the expansion of Cargill Meat Solutions and more than 36 acres for future manufacturing and industrial development.

Expansion of the Cargill Meat Solutions facility will support:

- The creation of 120 new full-time jobs.
- \$95,884,530 in associated capital investment.

The RISE cost per job assisted will be \$9,768.29, and there will be a total capital investment of \$81.80 for each RISE dollar requested.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the Commission, based on the capital investment and job creation commitments, award a RISE grant of \$1,172,195 of the RISE Fund or up to 80 percent of the total RISE-eligible project cost, whichever is less. Craig Markley, Office of Systems Planning, reviewed a RISE Immediate Opportunity application from the city of Ottumwa to construct a right-turn lane on U.S. 34 and reconstruct approximately 2,500 feet of Iowa Avenue from U.S. 34 north to Kay Avenue located on the east side of town. Proposed improvements will result in the creation of 120 new full-time jobs within three years along with almost \$96 million in associated capital investments. Average wage rate of the retained and created positions is \$15.24 which is 101 percent of the Wapello county average labor shed wage rate. RISE grant recommended is \$1,172,195 of which \$193,689 is from the county RISE fund and \$978,506 is from the city RISE fund. Local participation is 20 percent or \$293,049. Total cost is \$1,465,244. The RISE cost per job assisted is \$9,768.29, and total capital investment per RISE dollar is \$81.80. He introduced Nick Klimek, Ottumwa City Planning Director.

Mr. Klimek said the subject of this proposal is the modernization of the Iowa Avenue corridor to enable job creation and retention in the food processing sector. RISE funding would serve as a catalyst to fully modernize this corridor. Improvements separate from the RISE project include storm water infrastructure to separate the currently combined system, a redundant water line, and possibly fiber optics to support the businesses located in the corridor. Overall project investment will be the total eligible roadway cost included in the proposal; roadway improvements from Kay Avenue to Main Street not directly included in the proposal; related infrastructure improvements as previously mentioned; and approximately \$95 million in capital investment by Cargill Meat Solutions.

Mr. Klimek said Ottumwa has a positive track record of successfully implementing RISE projects including Kay Avenue and the 6th Street project at the Industrial airport. Both projects have been completed and are on track for job creation. They have strong partnerships with Indian Hills Community College as well as the Ottumwa Economic Development Corporation. Also, they have targeted an EPA brownfield assessment grant project to prepare an area of approximately 36.5 acres for redevelopment. This worthwhile project will serve as a catalyst for a \$95 million capital investment in a private industry, creation of 120 jobs, and will modernize an already highly productive economic development corridor.

Mr. Markley reviewed staff's recommendation.

Commissioner Miles moved, Commissioner Cleaveland seconded the Commission, based on the capital investment and job creation commitments, award a RISE grant of \$1,172,195 or up to 80 percent of the total RISE-eligible project cost, whichever is less. A maximum of \$193,689 is to come from the county share of the RISE fund and a maximum of \$978,506 is to come from the city share of the RISE fund. All voted aye.





Craig Markley, Office of Systems Planning, reviewed a RISE Immediate Opportunity application from the city of Allison to assist in construction of an approximate 720-ft. extension of Oak Street north from the end of the existing pavement located on the southeast side town in their industrial park. Because this project will provide access to more than 10 acres for industrial purposes and to maximize RISE support for the project, staff evaluated the application as a RISE Local Development project. Under RISE Local Development criteria, this project scored 44 points. The total estimated project cost is \$310,950, and the city is requesting a RISE grant of \$155,475 and will provide a 50 percent local match. 

Craig Markley, Office of Systems Planning, said Iowa's Clean Air Attainment Program (ICAAP) came as a result of the creation of the Federal Congestion Mitigation and Air Quality (CMAQ) improvement program in ISTEA (Intermodal Surface Transportation Efficiency Act). We have \$4 million in CMAQ funding set aside annually for ICAAP; although, for this round we are reallocating some recently returned funds due to a project not materializing. This is an application-based program that awards funds to projects with the highest potential for reducing transportation-related congestion and air pollution. Project priorities include reducing vehicle miles of travel and single occupant vehicle travel, improving vehicle traffic flow, or other projects that improve air quality and/or reduce traffic congestion. Projects are also evaluated based on their cost effectiveness.

Mr. Markley said in this round we received 15 applications requesting over \$7.5 million in funding. Last month the Commission heard staff's recommendation to fund 12 projects with \$4,162,804, and he requested Commission approval of the ICAAP funding recommendations.

Commissioner Cleaveland moved, Commissioner Reasner seconded the Commission approve Iowa's Clean Air Attainment Program funding recommendations as listed. All voted aye.

Craig Markley, Office of Systems Planning, said the Transportation Alternatives program was created in MAP-21 legislation to provide funding for a variety of alternative transportation projects and replaces the funding from pre-MAP-21 programs including Transportation Enhancements, Federal Recreational Trails, Safe Routes to School and several other discretionary programs such as the National Scenic Byway Program. This funding supports community-based projects to expand travel choices and enhance the transportation experience by supporting bicycle, pedestrian, cultural, historic, aesthetic and environmental projects relating to surface transportation infrastructure. Based on a Transportation Commission decision, the Department has reserved \$1 million for statewide projects with the remaining funds distributed to lowa's nine metropolitan planning organizations (MPOs) and 18 regional planning affiliations (RPAs) for their selection of projects of regional significance.

Mr. Markley said in this round we received 16 applications requesting almost \$4.5 million. Last month staff reviewed with the Commission our recommendation to fund six projects with \$977,502, and he requested Commission approval.

Commissioner Miles moved, Commissioner Rielly seconded the Commission approve the statewide Transportation Alternatives program funding recommendations as listed. All voted aye.
