ITEM 1. Adopt the following **new** subrule 761—400.53(4):

400.53(4) Special truck sticker. An owner of a special truck, registered pursuant to Iowa Code section 321.121, and issued either regular registration plates or special registration plates other than special truck registration plates must obtain from the county treasurer a sticker which distinguishes the vehicle as a special truck. The sticker shall be affixed to the lower right corner of the rear registration plate. EXCEPTION: If the vehicle displays front and rear plates, two stickers shall be issued with one sticker affixed to the lower right corner of the front plate and rear plate. For natural resources plates, the stickers must be affixed to the lower left corner of the front and rear plates.

ITEM 2. Amend rule 761—400.53(321), implementation sentence, as follows:

This rule is intended to implement Iowa Code sections 321.34, 321.40, 321.41, 321.121 as amended by 2011 Iowa Acts, Senate File 312, section 3, and 321.166.

ITEM 3. Adopt the following **new** rule 761—401.18(321):

761—401.18(321) Combat infantryman badge, combat action badge, combat action ribbon, air force combat action medal, combat medical badge, fallen peace officers and civil war sesquicentennial plates. Following is the application and approval process for special plate requests under Iowa Code section 321.34 as amended by 2011 Iowa Acts, House File 651, section 2.

401.18(1) Design.

a. The plates shall be a standard background plate with a distinguishing processed emblem specific to each plate type, consistent with processed emblems approved pursuant to rule 761—401.15(321).

- b. The distinguishing processed emblem shall be limited to 3" x 3 $\frac{1}{2}$ " on the registration plate.
- c. A distinguishing processed emblem owned or subject to legal rights of another person will not be used unless the department receives certification from the person that allows use of the emblem. The certification must include a statement holding the department harmless for using the emblem on a registration plate.
- d. The office of vehicle services may consult with other organizations, law enforcement authorities, and the general public concerning distinguishing processed emblems.
- 401.18(2) *Production*. None of the special registration plates subject to this rule will be manufactured or issued until 250 paid applications are submitted to the department. This minimum order requirement applies to each of the special registration plates subject to this rule. Each application must be accompanied by a statutory start-up fee.
- 401.18(3) *Discontinuance*. If 250 paid applications for any special registration plate subject to this rule are not submitted within one year after the date the department makes the plate available for application, the department shall report that fact to the legislature and request authority to discontinue the special registration plate at the next regular session of the general assembly.
 - 401.18(4) *Application process*.
- a. Applications for either letter-number designated or personalized combat infantryman badge, combat action badge, combat action ribbon, air force combat action medal, or combat medical badge special registration plates shall be submitted to the department on a form prescribed by the department. The applicant shall attach to the application a copy of an official government document verifying award of the combat infantryman badge, combat action badge, combat action ribbon, air force combat action medal or combat medical badge to the applicant.
- b. Applications for letter-number designated civil war sesquicentennial or fallen peace officers special registration plates shall be submitted to the county treasurer.

c. Applications for personalized civil war sesquicentennial or fallen peace officers special registration plates shall be submitted to the department on a form prescribed by the department.

401.18(5) Characters. Plates are limited to five characters. Personalized plates shall

consist of no less than two nor more than five characters and shall be issued in accordance with

subrule 401.6(2), paragraphs "a" to "d."

401.18(6) Reserve the right. The department reserves the right to approve or disapprove

any application.

ITEM 4. Amend 761 Chapter 401, implementation sentence, as follows:

These rules are intended to implement Iowa Code sections 35A.11 as amended by 2011

DISCUSSION/BACKGROUND:

The city of Fort Dodge submitted a RISE Local Development application in the February 2011 round requesting a grant to assist in the relocation of approximately 760 feet of Second Avenue South (Business U.S. 169/Iowa 926) connecting into First Avenue South from Fourth Street to Sixth Street in the center of town. As part of the downtown revitalization, this relocation will allow for the transition of First Avenue South from a one-way to a two-way street configuration. This project will provide the necessary transportation access to support the construction of new office buildings for RISE-eligible development. This project is anticipated to be completed by October 2012.

The evaluation and rating for the project will be discussed.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the Commission, based on the capital investment commitment and potential for future job creation, award a RISE grant of \$926,575 or up to 50 percent of the total RISE-eligible project cost, whichever is less, from the city share of the RISE fund.

Craig Markley, Office of Systems Planning, reviewed a RISE local development application from the city of Fort Dodge to relocate approximately 760 feet of 2nd Avenue South, better known as business U.S. 169 and Iowa 926, connecting into First Avenue South from Fourth Street to Sixth Street in the center of town. As part of the downtown revitalization, the relocation will allow for the transition of First Avenue South from a one-way to a two-way street configuration. The project will provide the necessary transportation access to support the construction of new office buildings for RISE-eligible development. Under RISE local development criteria, this project received a rating of 45 points. The total estimated cost is \$1,853,150, and the city is requesting a RISE grant of \$926,575 and will be providing a 50 percent local match. He introduced Chad Schaeffer, Fort Dodge City Engineer.

In doing some research prior to starting this project, Mr. Schaeffer said they found a similar design in the 1970s where they were considering a cross-town connector utilizing the overpass in Fort Dodge to get from the east to west side of town. They started in 2007 with a downtown plan which concluded in 2008 and received council approval. The plan focused on revitalization of the downtown, trying to bring more business to their community. Seven goals were identified consisting of condensing the downtown because they can't support the existing large downtown area; improving accessibility; increasing traffic counts; creating catalyst project opportunities; reconfiguring obsolete properties; compatible uses; and developing a cross-town roadway from the east to west side that includes the railroad overpass.

Mr. Schaeffer said they hired an engineering consultant to move forward with an impact study which was concluded in 2010. They included DOT staff in round table discussions they had over a nine-month period regarding how the plan would affect lowa 926 and impact properties, etc. He noted what is shown is a small piece. The ultimate project could include up to eight acres of property acquisition with demolition, environmental clearances, etc., and seven blocks of roadway reconstruction to First Avenue South. The total estimated cost is about \$7.6 million which is a large investment for the city of Fort Dodge. The design will accommodate transit activities and vehicle/bicycle/pedestrian activities so it will be multi-modal.

Stephanie Sheetz, Business Affairs and Community Growth Office, Fort Dodge, reviewed past RISE projects the city has done. In 2002 the Commission awarded a RISE grant for a 30,000 sq. ft. expansion of Silgan with 32 new jobs. Today they have 180 employees at this facility. Decker was part of a RISE grant in 2005 for a 30-40,000 sq. ft. headquarters office that created four new jobs and retained 75 jobs. Today they have 254 employees. Their past shows they have been successful in implementing the goals they had for the RISE grants. Mr. Markley reviewed staff's recommendation.

Commissioner Cleaveland moved, Commissioner Blouin seconded the Commission, based on the capital investment commitment and potential for future job creation, award a RISE grant of \$926,575 or up to 50 percent of the total RISE-eligible project costs, whichever is less, from the city share of the RISE fund. All voted aye.



Craig Markley, Office of Systems Planning, reviewed a RISE immediate opportunity application from the city of Dallas Center to construct left-turn lanes on lowa 44 on the east side of town to support the expansion of Pioneer Hi-Bred International Inc.'s existing facility. The proposed improvement will result in the creation of 20 new jobs within two years along with \$4 million in associated capital investment. The average starting wage of the positions to be created is \$53.50 per hour which is 252 percent of the Dallas county average wage rate of \$21.24 per hour. The recommended RISE grant is \$200,000; local participation is 57 percent or \$261,600; total cost of the project is \$461,600; the RISE cost per job assisted is \$10,000; and the total capital investment per RISE dollar is \$20. He introduced Mayor Mitch Hambleton.

Mayor Hambleton introduced council member Gary Stevens. He noted participating by telephone are Linda Schaut, Executive Director, and Julie Einck, project manager, Greater Dallas County Development Alliance.

Mayor Hambleton said Dallas Center has identified agri-research facilities as their main targets for growth of existing business and new business attraction so it is with great pleasure to see one of their existing businesses in this sector continue to grow in their community. With this growth and the activities surrounding the project, there is a need to move the increased traffic flow off lowa 44 onto interior streets in Dallas Center to allow safe access to the project. A traffic impact study was commissioned to determine the best way to handle the traffic flow. Recommendations from this study justified turning lanes to assist in traffic flow and safety. There will be 20 high quality jobs created with the expansion plans of Pioneer which will assist with some of the funding needs from the RISE program. Dallas Center has also requested funding assistance through U-STEP (Urban-State Traffic Engineering Program) and they are working with the District 4 DOT office with their request for additional assistance to improve the safety in this area. The remaining funding needed to complete this project will be derived from the city. All utility infrastructure is in place to foster growth in this area.

Mr. Markley reviewed staff's recommendation.

Commissioner Miles moved, Commissioner Yanney seconded the Commission, based on the capital investment and potential for future job creation, award a RISE grant of \$200,000 or up to 80 percent of the total RISE-eligible project cost, whichever is less, from the city share of the RISE fund. All voted Aye.


