INFRASTRUCTURE INVESTMENT AND JOBS ACT

Infrastructure Bill Status

- Infrastructure Investment and Jobs Act (IIJA)
- Passed the Senate (69-30) and House (228-206)
- President Biden signed Nov. 15
- Includes reauthorization of surface transportation programs for FFY 2022 to FFY 2026.
- Includes \$550 billion in new funding with half going to transportation
- Operating under a continuing resolution through
 Feb. 18, 2022, for FY 2022

Bottom Line Up Front

- Roads/Bridges: Iowa share is \$3.8B over 5 years, approx. \$764M annually for roads/bridges
- Roads/Bridges: About 30% increase over current fed aid levels
- Transit: Approx \$310M for public transit to Iowa
- Aviation: Total approx. \$25 billion nationwide (via grants and formula funds)
- Waterways: \$17B to USACE
- Rail: Approx \$15B rail programs, \$66B in passenger rail

Transit Programs

- Bus and Bus Facilities formula program plus-up
- Bus and Bus Facilities competitive program plus-up
- Low or No Emission grants plus-up



Aviation Programs - \$25B over 5 yrs

- \$15 billion for airport infrastructure grants (formula distribution w/ local match), new program
- \$5 billion for new "airport terminal grant" (competitive grants w/ local match), new program
- \$5 billion for FAA facilities and equipment

Rail Programs - \$15B over 5 years

- "Railroad Crossing Elimination Program"
 - New, competitive for states, MPOs, local govs, etc. for hwy/rail or pathway/rail grade crossings
- Consolidated Rail Infrastructure and Safety Improvements (CRISI)
 - Plus-up to existing program
- Federal-state partnership for intercity passenger rail (was SOGR)
 - Plus-up and changes to existing program (new capacity)
- Approx \$66B for passenger rail

Freight and Multimodal Programs

- "National Infrastructure Project Assistance" (\$5B)
 - New, competitive for states, MPOs, etc., mega-projects, incl. intermodal
- INFRA (\$8B)
 - Plus-up and changes to existing program (multimodalism)
- RAISE (\$7.5B)
 - Plus-up to existing program
- SMART grants
 - New-ish, competitive for states, MPOs, transit agencies, etc., technology for safety, efficiency

Other New Programs

- Carbon Reduction new core formula program, wide variety of projects, such as transit
- PROTECT new core formula program, resilience projects (also competitive funds)
- Charging and Fueling Infrastructure new, \$5B
 - Application-based –EV, hydrogen, propane, natural gas
 - Formula to states –EV only
- Bridges new, \$9.2B
 - · Competitive large public bridges and small bridge bundling
 - Formula –program for bridges on public roads



How will the funds flow to lowa?

- Highway/Bridge
 - All \$ through Iowa DOT
 - Funds allocated by Iowa Transportation Commission to DOT/cities/counties. Involves lots of stakeholder outreach.
 - Challenge: Impact on swap program
- Transit
 - Larger metros, directly from FTA to the transit agency
 - All other transit \$ flow through lowa DOT to transit agencies
- Aviation
 - Directly from FAA to eligible public airports in Iowa
- Rail
 - Competitive grants, Iowa DOT assists and coordinates
- Waterways directly to USACE

When will the funds flow to lowa?

- Two methods
 - 1. Advance appropriations for some new programs and competitive grants, right away
 - When appropriated by Congress traditional for 5 year surface transportation bill, takes time
- DOT evaluating program amendment for near term action
- DOT preparing for discretionary grant applications
