How A Former Employee of the Multi-State Lottery Hijacked The Jackpot

\$16.5 million dollars. That's how much was in the jackpot in 2010, when Eddie Tipton won the lottery after buying the ticket in a Des Moines convenience store. As the security chief at the Multi-State Lottery Association at the time, Tipton was unable to claim the money. He hired a law firm to deliver the winning ticket and keep his name anonymous -- but by then the Iowa Lottery had already suspected something fishy was going on. Tipton had masterminded the biggest lottery fraud in US history.


