#### MISSION STATEMENT

#### The Iowa Mississippi River Parkway Commission (IAMRPC) was organized to:

- Preserve, promote and enhance the scenic, historic, natural, archaeological, cultural and recreation resources of the National Scenic Byway (NSB)/Iowa Great River Road (GRR) and the Iowa Mississippi River Valley.
- Foster economic growth of the Mississippi River corridor.
- Develop the National Scenic Byway/Great River Road.

#### **GOALS AND OBJECTIVES**

- Assist in coordinating the increase of investment and awareness of the National Scenic Byway/Iowa Great River Road and its amenities with roadside parks, scenic overlooks, educational experiences and opportunities and historic information.
- Increase the awareness for stakeholders of funding through transportation enhancement funds.
- Develop communication opportunities to tell the stories of the National Scenic Byway/Great River Road.
- Arrange community involvement meetings and workshops.
- Advocate for the Great River Road development studies.
- Advocate for transportation related projects that incorporate the principles of context sensitive design.
- Advocate for the use of sustainable design principles such as L.E.E.D. (Leadership in Energy and Environmental Design.)

A major factor in achieving these goals and objectives is partnering with area and national groups and associations that have similar goals and interests. By networking with other organizations, we can best utilize all our assets, including financial, contacts, and personnel.

#### **IOWA MRPC COMMISSION MEETINGS**

The Iowa MRPC met on 5 separate occasions in the past year. July 26, 2012 at the Mississippi River Eco Tourism Center in Camanche, September 28, 2012 at the national MRPC meeting in Louisville, Kentucky, February 7, 2013 at the Bettendorf, IA public library, March 21, 2013 at the Lodge in Bettendorf, IA and April 27, 2013 at the Isle of Capri Hotel in Bettendorf, IA as a part of our national semi-annual meeting of the MRPC. The minutes of each of those meetings are included in this report.

#### **IOWA MRPC STRUCTURE**

The Iowa Commission consists of ten commissioners appointed by the Governor of Iowa representing the ten counties that border the Mississippi River. The commission by Iowa statue is gender and politically balanced. In addition, there are five technical members representing: Iowa Department of Transportation, Department of Economic Development, Iowa Department of Natural Resources, Iowa Office of Tourism, and U.S. Army Corps of Engineers.

The commission has received verbal commitments from the Iowa Department of Economic Development and Tourism to appoint new commissioners but as of the date of this report no formal appointment has been completed.

An updated Iowa MRPC commission list is attached.

#### **IOWA MRPC BUDGET**

The FY2012 budget for the Iowa MRPC was approved by the Iowa DOT for \$40,000. (see highlights). The budget includes 2012 National MRPC dues, National Scenic Byway Grants matching funds, MRPC conferences and Iowa Commission meetings and travel expenses, office expenses, mailings, and telephone long distance expenses.

#### **IOWA ACTIVITIES AND WORK PLAN**

#### **Iowa MRPC Website Development**

The Iowa MRP website continues to evolve. <u>www.iowagreatriverroad.com</u> The host, Dubuque365.com continues to add content to the site.

Features of the website include:

#### For the Traveler:

- A history of the MRPC, biographies of members and mission statement.
- A history of the river, towns, and counties with appropriate photography.
- Fantastic photography and panoramic photos of the Mississippi River.
- Schedule of events that can be sorted by date, location, type, etc.
- Mapping ability and ability to zoom in on maps and select location links.
- An itinerary or trip planner that prints an agenda by city, type of event, etc.
- Ability to feature links with maps and icons and print a route with mileage.

#### For the Iowa Stakeholder:

- Easy to use and update with 100% immunity to viruses.
- Unlimited addition and editing of pictures and text.
- Fully managed, Tier-1, secure fiber-optic website and email hosting facilities.
- Ability to support advertising or sponsors for maintaining the site.

#### **NSB Grants submitted by Iowa Stakeholders**

The Iowa MRPC reviewed several NSB grants submitted for the Iowa Great River Road funding and sent recommendations for funding to the Iowa DOT.

#### **Iowa MRPC Corridor Management Plan**

As reported in our 2010-2011 report, the Iowa MRPC received a \$260,000 National Scenic Byway Grant for the purpose rewriting and modernizing the CMP for the Iowa Great River Road. The Iowa MRPC hired David Dahlquist and Associates as consult to construct this new CMP. Much work has commenced in this effort. A new reference library of materials related to the Iowa Great River Road has been developed by Dahlquist and Associates which can be accessed via the internet. Work continues in 2012/2013 by Dahlquist and Associates in structuring the new CMP. This year our consultant is performing visitor surveys at a number of locations along the Great River Road including many of the Interpretive Centers in an effort to better identify the travelers along our byway, both local residents and those that have traveled a great distance. Dahlquist and Associates has also been working to organize and expand the Iowa MRPC stakeholder list Our stakeholder list now has over 1100 contacts, most of which can be contacted via electronic communication.

#### **Great River Road Interpretive Centers**

The Eco Tourism Center in Camanche, Iowa located in Clinton County has applied successfully to the National MRPC to be recognized as an MRPC Interpretive Center. This site has been added to the National MRPC Interpretive Center list as an attraction in 2012 and has been included in our Great River Road Map as a certified visitor center. The Center received official recognition in a ceremony at the Mississippi River Museum in Dubuque during the National MRPC semi-annual meeting in April.

#### **Explore our Great River Map**

The Iowa MRPC approved and developed a new byway map which is included in this report. The 8 ½" by 14" map has been distributed to our welcome centers, interpretive centers and others along the byway. The map was developed in a tear-off format for the convenience of travelers and users. The new format was inexpensive and allows for easy updating in the years ahead. This was also included in our prior report. We want to be sure a map of the Iowa Corridor is included in every annual report. In 2013 the Iowa MRPC updated these tear-off maps to include the updated Interpretive Centers.

#### **Iowa Participation in Meetings and Events**

The Iowa Chair and or his proxy participated in all National MRPC Board meetings and Executive Board meetings, as well as the Semi-Annual and Annual Meetings. The majority of Iowa Commissioners also participated in the National MRPC meetings.

#### **MRPC** Annual meeting

The National MRPC I meeting was held in Louisville, KY with significant participation from the Iowa membership.

#### Iowa MRPC "Along the Byway" Newsletter

The Iowa commission published two newsletters for our stakeholders this year. The publication, which is still mailed to recipients, highlights grant opportunities for river communities, tells the success stories of river projects, and communicates the advocacy role of the Iowa volunteers and technical advisors of the MRPC. Copies of those newsletters are included in this report. Our newsletter was also distributed electronically via Constant Contact to a significant numbers of our stakeholders. This is a very convenient and money saving method to distribute our newsletter.

#### **Iowa MRPC Stakeholder Meetings**

The Iowa MRPC did not schedule stakeholder meetings in 2012 but will schedule several meetings in 2013. The meetings will again focus on the update of the Corridor Management Plan and our progress in finalizing that document.

#### Iowa Activities –

The National MRPC signed on as a sponsor of the Great Race which took place this year, 2013, along the entirety of the Great River Road. Iowa Commissioners participated in the 2 events held in our state including a luncheon hosted in Dubuque and a ceremony which took place on the riverfront in Davenport. Commissioners welcomed participants and provided maps and material about Iowa's Great River Road and its attractions.

National Scenic Byway Grants for 2012-2013 -

Great River Road Mississippi River Trail in Riverdale – Scott County - \$494,956

- Troy mentioned that on page 3 the motion to accept the budget was made at the previous meeting.

#### Financial: Troy Seifert

- No expenses were processed in the last quarter so the balance remains at \$40,000
- Regarding the last request for Dahlquist & Associates, we ran to the limit last fiscal year so MRPC owes them approximately \$912.
- Patsy asked Troy if his department has deferred expenses. Troy answered "no".
- MJ moved and Jay seconded to except the preliminary budget. Carried.
- In regards to those going to the National Meeting in Louisville, MJ and Patsy are not an expense to us as their expenses are paid by National. John G will be staying with his brother so we will not incur any expenses. Jay, Edith, Jane, Deb, and John O. plan to attend. Patsy and/or MJ offered their rooms to share as their rooms are paid by National.

#### Strategies for Fundraising for the CMP Plan: John Goodmann and David Dahlquist

- See Attachment 2 IGRR Corridor Management Plan Update/Local Match Considerations/2-9-12 from David
- We need a plan to solicit funds from the ten counties to accelerate the planning process/drawdown of the federal amount. The in-kind amount (\$5,000) has been fulfilled.
- David & Bre made a draft sales pitch (Attachment 2). It was suggested to change order 1 is the same, 2 is 8, 3 is 6, 4 is 7, 5 is 5, 6 is 2, 7 is 3, and 8 is 4. Bre will change the order.
- It was suggested to get a boilerplate for certain groups. See Attachment 3
- Troy has the document stating how much money each county has received and he will send this pdf to Bre for inclusion in the sales pitch.
- We need a cover letter that should go on our stationary. Bre will prepare this. We can adjust it depending on the recipient. MJ has a cover letter that she will send to Bre.
- The deadline for getting letters out will be September 27<sup>th</sup>. Bring to the National meeting an inventory of who has been solicited, any responses and checks.
- Jane sees our stakeholders as businesses, i.e. hotels, banks, restaurants, Historical Societies,
   Chamber of Commerce groups, Convention and Tourism offices. Cities, County

- Conservation Boards, campgrounds, previous recipients, hospitals, and industries (we may have to write grants for industries).
- We should ask our Board of Supervisors for their support, a letter, rather than money if they are unable to contribute financially.
- MJ had July numbers: International tourists spent \$153B in 2011 and that is 14% over 2010.
   MJ distributed Attachment 4. The Mississippi River is the third most requested destination.
   This information could go into the cover letter.
- Part of what we send out could be asking for suggestions on who would be potential contacts for solicitations.

#### Planning for the National Meeting in 2013: Patsy Ramacitti and John Goodmann

- John wants to use the Quad Cities as our base because of financial, travel, and accommodation reasons.
- Patsy met with April Boyer and Nancy Donovan of Isle of Capri. (Attachment 5)

- Edith moved and Jay seconded to shoot for Option #3, Thursday-Saturday.
- For the Hospitality Suite, each commissioner should bring some food/beverages produced in their county. Jay will chair the Hospitality Suite Committee. Edith will help. MJ will bring two cases of home brew. John G. to get Templeton Rye.
- Thursday will be lunch in a bag at reservation.
- It was suggested to have a band on Thursday night. We could get the River 6 Band. Another suggestion was to have a costume night where you dressed as your favorite river person. We could have a taste of Iowa meal.

- iv. Right-of-Ways & View shed Management-vegetation management.
- v. Visitor Services-provide everything visitors expect i.e. restrooms, gas, information, accessible
- vi. Livability Development-How do byways add to the qualities of local communities & economic impact
- Performance Levels: Then has list of level of performance in these areas.
- Actions:
  - i. Informed non-action-decide at this time not to do anything, but we are aware of it
  - ii. Monitoring-Just watch for awhile
  - iii. Proactive Communication-Stay on top of the item and inform stakeholders of what is happening with it.Events & Festivals using website or constant contact.Just delivering info to people
  - iv. Cooperative Services Agreement-have partner who will fulfill this need. i.e. don't have formal agreement with DOT, but they provide and install new signs, State Parks may offer management for IC, but there are some things we want them to do, contract with Dahlquist, website.
  - v. Management of Funded Projects-These have time limits. It's a way to get activities or actions done
  - vi. Development of Financial Resource-Takes more effort
  - vii. Continued Program Operation-Takes more effort. Year after Year, we are continually funding this activity.
- 2. Individual Action Suggestions:
  - We all submitted our ideas and David put them on the matrix.
- 3. Refinement
  - We indicated with green and red stickers if we liked where the activity was placed in a certain performance level.
- 4. Overall Observations
  - David said we should work with Regional Planning
    Associations and Metropolitan Planning Organizations because
    IDOT has delegated the responsibility of choosing who get
    grants to these groups instead of the DOT. They have \$3.4M
    (mainly for infrastructure) so you could get 50% from RPO,
    30% could come from IDOTs discretionary fund (\$1M), with

the remainder being matched. This is for 2013 and 2014 funding, but since the RPAs and MPOs have a 1-year delay, this money will be available for 2014 and 2015. Now there is \$250,000 in State funding for by-ways specifically and it's suggested they add another \$250,000. Matching is required. We would be able to apply. We could apply for implementation of our CMP out of the \$250,000.

- There is a meeting Feb 19<sup>th</sup> 9:00 at Holiday Inn in Ames.
   They are bringing in some by-way people. We need several commissioners to attend. Craig will send an e-mail to us.
   David and Bre would be able to attend.

Our state meeting on Saturday, April 27 at 8:00 a.m. will be held at the Calypso Café in the Isle of Capri from 8:00 to 9:00. John will have all new tear off maps at that meeting ready to hand out to each commissioner to take back to our counties.

Deb Arp will make a presentation Friday during the General Session on Map 21 on behalf of lowa DOT. Jay will introduce Deb on behalf of the Transportation Committee. Carol Zoff of MN DOT and MN MRPC commission will lead a discussion panel at this time also.

Lyn Pilch/National Office will lead discussion on the MRC update and the 10 State Partnership Program regarding Japanese Tourism. Update on the Commerce Department grant to the MRC for \$250,000 will be made at this time also.

John Goodman will give the State Report for Iowa as the final presentations from the States are made on Saturday morning during the General Session.

Action: All Iowa MRPC commissioners will meet on April 25 at Noon in the Calypso Room in the South Tower at the Isle of Capri for a work session prior to the Opening of the Semi Annual 10 State MRPC that afternoon. (Patsy will make arrangements for a table to accommodate our group lunch)

Discussion was held regarding the expense of the lowa Facebook Contest winner that the 10 States Marketing Committee had given approval to the National Office staff to run on Facebook this past fall. It was a contest requesting entrants from Friends on Facebook of their favorite food they have eaten at restaurants along the GRR. Each State agreed to provide a gift basket for one of the 10 winners and the basket was to have a \$100 value. Patsy stated this was never approved by the National Board. Several of us advised Patsy that each State agreed to provide a \$100 gift basket whether that is by "free donations" or purchasing items to include in the basket. Edith Pfeffer had a bill to present for her items contributed to the basket. Jane and MJ reminded the board we are in the business to promote the GRR and this was a promotion of the GRR. Patsy moved/MJ seconded for authorization of up to \$150 for expenses of items and shipping costs for our participation in the marketing committees Facebook Contest and to have IDOT move that appropriation of dollars to the marketing line item in the budget. Motion Passed with all ayes.

John Goodman reported that the funding for the Iowa MRPC which was in great jeopardy in the transportation bill of the Iowa Senate will remain in the transportation budget. Brian Moore from Jackson County advised Edith that the Iowa MRPC needs to continue to educate legislators and provide

face to face updates to the State Senators and Representatives. The President of the Senate Pam Jochims assured Goodman they understand the purpose of the MRPC and we will remain funded. Edith restated we need to work both sides of House and Senate and discuss what we are about. Our own representatives on the GRR must be kept in the loop.

Patsy and Deb Arp led discussion on the Federal DOT dollars that will be funneled from IDOT to the Regional Planning Organizations. Deadline for application is April 15<sup>th</sup> for the small \$1,000,000 Statewide Program grant the Iowa DOT funds. The MPO's (municipal planning organizations) and RPO's (regional planning organizations) all handle their own deadlines for their money. This small Statewide Program would have been a perfect program for our signage. Is there something we need all along the GRR that is an eligible activity under transportation alternatives definitions? It will be too late for this year's deadline but keep this in mind for future funding from the Iowa DOT from this small Statewide Grant program. Deb Arp stated it is primarily for construction of such items as a pedestrian and bicycle facilities, conversion of abandoned RR to trails, outdoor advertising mgmt., rehab of historic transportation facilities, storm water mitigation or wildlife management related to highways, scenic turnouts and overlooks.

ACTION STEP: MRPC Commissioners in each of the Regional Planning Organizations territories are to meet and discuss talking points with the Executive Directors and Transportation Directors of the RPOs, engaging in discussion of what the RPO's have in mind to use their money on and what their procedures will be for applying for the dollars. This is our opportunity to discuss with the RPOs our role on the MRPC Pkwy and ask how we can work together to promote the GRR. May we serve as advisors to their technical committee for their transportation funds? Jane and MJ will go to UERPC. Edith and John Goodman will meet and talk to Chandra the Transportation Sr. Planner at Eastern Iowa RPO. John Oberhaus and Patsy will go to Muscatine and Scott Co and The Bi-State Commission. Jay, Debbie and Larry will go to SE Iowa Regional Planning Commission. We need to ask who the decision makers are on each RPO Board and continue discussions with them.

ACTION: Make reports of our meetings with the RPO's and send our findings to John Goodman by April  $19^{\rm th}$ . These must be done by this date. Make your contacts now.

Deb Arp will send our members the summary of the changes from Safety Lu to Map 21 for each member to read and understand before attending the RPO. All contacts must be made with the RPOs before the April meeting. Personally invite these people to the SA mtg or at least to Dubuque Opening Dinner Reception. Advise them we will be talking about MAP21 on Saturday April 27 during the General Session. Carol Zoff could have someone from a RPO in lowa to be on the panel on Saturday if any of our RPO Executive Directors would like to volunteer. If you get a volunteer contact John so that he can contact Carol Zoff.

RPA are Regional Planning Affiliations and MPOs are metropolitan Planning Organizations within the RPA.

John asked for a budget update from the lowa DOT but they did not have it available for our meeting. Jane gave the following update on the fundraising to date by our lowa MRPC for the match on the CMP grant. To date our checking account balance with all donations and a little interest earned is \$5,750.42. Total contributions to date have been \$6,652. One disbursement to Dahlquist and Associates. John commented that our State Budget of \$40,000 is appropriating dollars each year to our match as well.

Reminder to Commissioners: continue to ask from your County's that we have not heard from yet. Those contributing to date are Dubuque, Clayton, Clinton, Louisa.

Meeting called to order by Chairman Goodman at 11:10 a.m.

M.J. introduced her guest Lori Wallace (probable replacement for M. J. Smith in Clayton Co who is retiring from her position on the Commission as of June 30, 2013) Lori and her spouse have studios that they rent to tourists and boaters. They have three buildings across from the Lock and Dam and recently completed their third building. She also serves lunches to the Byway traveler.

Patsy reviewed the April business meeting minutes from April. Larry/Jane moved to approve the April minutes. Motion was approved.

Treasurer's report, Mary Stahlhut reviewed the Commissions budget and expenses fiscal year to date. Our fiscal year is nearing a close on June 30. Mary asked for approval of invoice received from Jay Schweitzer for expenses incurred with the Hospitality Room our Commission hosted during the National MRPC meeting in late April in Davenport. It was moved to approve expenses incurred for the Hospitality Room by Commissioner Jay Schweitzer for the hosting of the National MRPC meeting in April. John stated that the invoice for the reprinting of the revised MRPC Tear Off sheet had not been received yet but advised Mary this would be submitted by June 30th. Dave Dahlquist will have an invoice yet to submit as well as other commissioners with travel expenses that have not been submitted. Mary reminded everyone the fiscal year ends June 30<sup>th</sup> and to be sure and has all expenses shortly after that. Balance remaining in our budget is \$10,380.30. It was agreed that Mary could move dollars budgeted in various line items of the budget to where needed to finalize the 12/13 budget year. Move and seconded by Edith/M.J. to approve the Treasurer's report.

Jane reported on the CMP fund raising to date. This is the match needed to be raised by our commission for the completion of the CMP. It was set up that we match \$15,000 per year from our \$40,000 budget which represents our 20% match of the 80% draw on the Federal Grant. The CMP document is forecasted to have a status report sent to current Stakeholder/Contributors. Dave Dahlquist will prepare this document.

Discussion and clarification on the use of the \$500 grant monies that John applied for from the National Office. We still need to decide what we are going to use those dollars for.

Discussion on the GREAT RACE national event. Tyler Dougherty, from Dubuque Area Chamber of Commerce, suggested the MRPC act as hosts when the Great Race participants arrive at the Grand River Center in Dubuque on June 23, 2013, and will require about two hours of our time. We are to be at the Grand River Center at 10:30 Sunday morning to be sure our booth is set up and have all brochures available. The GREAT RACE officials will bring our tent from LaCrosse on the truck and will be set up for us when we arrive. The same is true for the Davenport LeClaire park overnight stop. It will take 3-4 MRPC Commissioners to staff our booth. Edith, John G, and Jane agreed to staff the Dubuque location.

Jay, Debbie J, Patsy, Edith, Larry and Jane will be available for Davenport. We are to welcome the race participants and advise people where they are to go for their lunch or dinner. The Quad Cities venue was reviewed by Patsy. Those helping in Davenport will be Edith, Larry, Jay, Patsy. Patsy stated Joe Taylor ordered CVB t-shirts to be worn at the News Conference and MRPC should wear their T-shirts at that conference as well. Jane had ordered T-shirts from the National Office prior to the meeting. They will be shipped to John Goodman for distribution to Patsy. John Goodman and Patsy will attend the News Conference on June 18 at LeClaire Park. Davenport has two other events occurring that day as well, a B-B-Que and Brew event and Show and Shine event in the Bix venue.

Dave updated the Commission on the inventory being done of the site surveys from MN line to Quad Cities and now scheduling in the next week more activity being done. The visitors' survey is moving forward and they are taking additional effort thru the survey with Becca onsite at different locations intercepting people. In addition to being focused for the traveler/visitor they will do a screening question if they are a resident of the area to pull a different list of questions for those that are not local visitors. This is to obtain a different perspective from the traveler vs. someone local. Dahlquist & Associates will continue to work with the survey locations and are making arrangements to be there at these locations throughout the summer.

Dahlquist suggested making contact with Stakeholders – He feels it is time to use the constant contact list and do an update to the Stakeholders. Brea will be prepared to use the quarterly newsletter that MJ will try to have ready in a couple weeks and coordinate their CMP update with that mailing. The contributors to the CMP project are to be included in the mailing as well as the State legislators. Dave will double check to be sure the State Legislators are all on the mailing list. Dave will send hard copies by mail to those we do not have an email for. The State Transportation committee should be included.

Stakeholders – Dave recommends that this fall we host a series of Stakeholder meetings again to give an update on the CMP to report on the visitor satisfaction survey, discuss the work sessions and framework done by MRPC, and discuss long range alternatives of the use of the CMP, obtain options and purpose of the CMP long term. These meetings will also allow the Stakeholder input on the core functions of the representative organization and its sustainability, and identify projects that local organizations can recognize as a priority. If they are listed in our CMP as a priority then local mayors, councils, and planning agencies can use this as a tool to identify what needs to be developed. Commissioners felt it is imperative the CMP become a useful tool to other organizations for their planning.

The WEBSITE – Investigate partnering with other By-Ways organizations. Mary Stahlhut will investigate with the By-Ways what our costs would be and if we can still join forces with the other By-Ways. Jane reported on the proposal received from Lora Friest at Northeast Iowa RC&D for their staff members to assist us with loading the sites and businesses along the GRR into the Iowa GRR website. Commissioners thought this would be too expensive for our very limited budget unless the Iowa DOT authorized additional funding to us it would be very difficult to raise the dollars needed to do this. Mary, John Goodman and Dave Dahlquist agreed to meet to discuss what options we might have with the Byways organizations and DOT assistance.

Mary reported of recent legislation done on Billboards. If DOT changes an Interstate and scenic byway road alignment and the no longer compliant sign is removed, it could be relocated but it would still have to be approved by DOT and finally approved by Federal Hwy in Iowa. This is a rare circumstance in Western Iowa and is not expected to become an issue for the GRR.

Edith reported on Cultural Affairs. All our commissioners responded to Edith and she thanked everyone. The Cultural Affairs National Committee is updating the signage at all Interpretive Centers on the Great River Road. Where signage has not been, new signs are being ordered and those in poor condition will be replaced.

Mary Stahlhut stated she was very proud of the Iowa Commission and the job well done hosting the National Board Meeting in April.

South of Dubuque visit St. Donatus founded by skilled stone masons from Luxembourg. Then discover Bellevue with a beautiful riverfront park extending the full length of the town. Watch towboats "locking through" or eagles feeding below the dam. Other sites include a historical museum, the Bellevue State Park with its limestone cliffs and renowned butterfly garden. Or experience nature hands on at the 18 acre Hurstville Lime Kilns Interpretive Center right off Highway 61. This 18 acre complex includes a wetland, reconstructed prairie, roadside observation deck, trails and bird blind.

### CLINTON COUNTY

Where the By-way meets the Lincoln Highway (U.S. 30), you will find Clinton. Our Riverview Park with the Lillian Russell Showboat Theatre, aquatic center, marina, band shell, and Alliant Energy Stadium, home to the Clinton Lumber Kings (class A baseball team) sits on the majestic Mississippi River ready to entertain a diverse range of guests. Just north on Highway 67 you can view the widest point on the upper Mississippi River from a viewpoint in Eagle Point Park. The Bickelhaupt Arboretum, the Felix Adler Children's Discovery Center, The Clinton County Historical Society Museum and the River Art Center are open for tourism activity. The new Candle Light Restaurant on the riverfront has a perfect view of Old Man River and offers eagle watching in the Winter. The Wild Rose Casino and Resort is located at the junction of Highway 30 and the Millcreek Expressway

#### SCOTT COUNTY

Visit the new IMAX® Theatre & Putnam Museum, Bettendorf Family Museum for children, Buffalo Bill Museum, and Fejervary Children's Zoo. Try your luck on the Isle of Capri Casino-Bettendorf or Rhythm City Casino-Davenport or take a cruise on the Channel Cat Water Taxi, Celebration Belle or Twilight. View agricultural exhibits at John Deere Commons. Enjoy festivals – Bix Beiderbecke weekend with Bix 7 and Junior Bix 7 road race, Jazz festival and street fair, and Mississippi Valley Blues Fest, Quad City Festival of Trees, Beaux Arts Fair. Shop at historic Village of East Davenport, quaint antique boutiques and two major shopping malls.

#### MUSCATINE COUNTY

Active and diverse, Muscatine is a community tucked between two river bluffs and is filled with many surprises. Come and experience our first-rate recreational facilities such as Wildcat Den State Park, Shady Creek, Fairport Fish Hatchery and Weed Park with the new Aquatic Center. Our renowned Muscatine Art Center and the History and Industry Center offer a glimpse of Muscatine's rich history. While you're here, don't forget to stroll along the streets of the historic downtown business district and visit the many unique retail shops.

#### LOUISA COUNTY

Louisa County is located at the confluence of the lowa and Cedar Rivers. The lowa River flows mostly southeast to near Oakville where it joins the Mississippi River. Naturally, the area is characterized by broad floodplains containing many wetlands and marsh areas including the Mark Twain Wildlife Refuge. The adjacent wooded bluffs were favorite sites for Native Americans because of the abundance of nearby forage, fish, wildlife and waterfowl. Toolesboro has a series of Indian mounds and a fine visitor center.

### DES MOINES COUNTY

Start your tour of historic Burlington at the Port of Burlington Iowa Visitors Center on the Mississippi by the imposing Great River Bridge. Visit the Catfish Bend Riverboat Casino and walk past the site of the First Iowa Territorial Capitol to the charming downtown West Jefferson Street Historic District. Tour the nearby Heritage Hill Historic District with its grand homes including the Phelps House, just one of three Des Moines County Historical Society Museums. Walk down famous curvy Snake Alley. Don't miss Burlington's beautiful parks with their stunning views of the Mississippi River.

#### LEE COUNTY

History lives on, by way of authentically dressed historic interpreters at Old Fort Madison, our accurate reconstruction of the first military fort on the upper Mississippi. Sharing the beautiful Riverview Park with the Fort, you'll also find Santa Fe Engine 2913 and the Old Santa Fe Debot Historic Center. You can also view the world's largest double-decker swing Span bridge, watching it open and close to allow barge traffic through and counting the nearly 100 trains that cross the bridge daily!

Launching a new planning initiative to fuel the economic engine that is the Iowa Great River Road – stakeholder meetings are announced

Since its designation by the U.S. Secretary of Transportation as one of only 150 National Scenic Byways in the United States, Iowa Great River Road projects have been awarded nearly 8 million dollars in grants throughout the 10 Iowa counties which border the Mississippi River.

Projects supported by these grants include the National Mississippi River Museum and Aquarium in Dubuque, the Clinton County Eco Tourism Center, the Louisa Interpretive Center in Louisa County, the restoration of the Fort Madison Depot, the expansion of the E.B. Lyons Interpretive Center in Dubuque, the marina in downtown Guttenberg, and a variety of trails and bike paths. The Iowa Great River Road is managed by the Iowa Mississippi River Parkway Commission, an organization created by the State of Iowa to steward and promote the route.

The Commission's members each reside in one of the 10 Iowa Mississippi River counties and are appointed by the Governor. The Iowa Great River Road is an important segment of the 10-state, 3,000-mile long national Great River Road meandering on both sides of the Mississippi River from Minnesota to the Gulf of Mexico. The National Mississippi River Parkway Commission and the Great River Road were established in 1938 under President Franklin Roosevelt.

### Stakeholder Meetings, continued:

Iowa MRPC Chair Goodmann continues, "For over a decade the Iowa Great River Road has attracted millions of dollars in federal, state, and local funding. Now the Commission needs its stakeholders to help plan the Great River Road's next chapter of growth and effectiveness."

The business and development plan for a byway is technically called a "corridor management plan", a document which guides resource protection, marketing, partnership organizing, and strategies for sharing the unique culture and history of the byway. The original Corridor Management Plan was written in 2000 and has supported many communities and organizations in their efforts to secure federal funding and local dollars to develop projects throughout the 10 counties.

The Iowa Mississippi River Parkway Commission was awarded a National Scenic Byway Program grant in 2011 to update the aging plan and has hired the firm of David L. Dahlquist Associates of Des Moines, a national leader in byway planning, to develop a new corridor management plan for the Iowa Great River Road. The planning process will take approximately 2-3 years and will focus on building and strengthening partnerships throughout the region and identifying innovative strategies for attracting visitors and enhancing the livability of communities along the Iowa Great River Road.

"Every Mississippi River community, county, economic development group, public agency and non-profit organization has a stake in the future of the lowa Great River Road. Their representatives need to voice their ideas for how the Great River Road can best serve stakeholders and visa versa," urged Patsy Ramacitti, Pilot Emeritus of the National Mississippi River Parkway Commission.

Informative stakeholder meetings will be 90 minutes long and interested citizens are encouraged to attend whichever session is most convenient, regardless of where they live.

### MEET JANE REGAN ALLAMAKEE COUNTY COMMISSIONER





### National Scenic Byways Program Grants Recently Celebrated

The Iowa Mississippi River Parkway Commission along with the Iowa Department of Transportation are proud to announce that the Federal Highway Administration and the US Secretary of Transportation have awarded the following National Scenic Byways Program Grants to projects associated with the Iowa Great River Road. In this last round of discretionary funding offered exclusively to byways, the accumulated value of the grants award to the Iowa Great River Road was the largest amount awarded to any byway in the United States.

**lowa Great River Road National Scenic Byway Signage-\$346,160** to support new byway signage throughout the ten river counties in Iowa.

**Great River Road and Driftless Area Byway Visitor Center -** \$1,361,400 to develop a new visitor center with traveler amenities on the Great River Road National Scenic Byway, overlooking the Mississippi River Valley at Lansing.

**Great River Road Marquette Overlook - \$332,800** to improve the Marquette-Joliet Bridge scenic overlook observation deck.

**Great River Road Port Louisa Rest Area - \$200,000** provides a rest stop for byway travelers with interpretation of Mississippi River

### Results are in! Iowans love a beautiful drive.

Findings from the IOWA 2012 SURVEY FOR THE STATE COMPREHENSIVE OUTDOOR RECREATION PLAN (SCORP), which was conducted for the lowa Department of Natural Resources, has been released.



The study entailed a telephone survey of randomly selected lowa residents.

### How do lowans participate in outdoor recreation?

The highest rates of participation are in walking (89%), picnicking, barbecuing, or cooking out (83%), driving for pleasure (56%), family oriented activities other than picnicking, barbecuing, or cooking out (52%), swimming (49%), fishing (46%), and observing, feeding, or photographing wildlife around or within 1 mile of home (44%).

The Iowa MRPC, together with you our stakeholders, advocates for the Great River Road, a byway recognized nationally for its driving pleasure.

### National Scenic Byways Program Changes

The federal program, which has supported multiple national scenic byway projects in communities along the Great River Road (like those announced at the top of this



newsletter) has been discontinued. Iowa Department of Transportation (DOT) staff have been studying the way forward through implementation of the Transportation Alternatives Program (TAP). Recommendations will likely be considered at the January 2013 of the Iowa DOT Commission.

cross-country trip. The course instructions require the competing teams to drive at or below the posted speed limits at all times.

### How does the Great Race work?

Each day the driver and navigator team receives a set of course instructions that indicate every turn, speed change, stop, and start that the team must make throughout the day (usually 220 to 250 such instructions per day). Along the course route there will be from 4 to 7 checkpoints recording the exact time that the team passes that point. The objective is to arrive at each checkpoint at the correct time, not the fastest. The score for each team is the result of the team's ability to follow the designated course instructions precisely.

### The Iowa Mississippi River Parkway Commission is excited to celebrate the 75th Anniversary of the Great River Road National Scenic Byway.

In 1938, the governors of the 10 river states developed the concept of a transcontinental Great River Parkway along the Mississippi River. Choosing to conserve precious resources, among them land, time and dollars, they decided rather than building a new continuous road, the existing network of rural roads and then-fledgling highways that meandered and crisscrossed the river would become the Great River Road. The green Pilot's Wheel road sign that marked the route of the new byway more than seven decades ago still heralds the road today.

As one of the oldest, longest and most unique scenic byways in North America, the Great River Road offers respite to millions of travelers seeking a getaway - from a leisurely day's drive to an extended vacation. Nearly 3,000 miles long and running through 10 states along the Mississippi River, the Great River Road has offered a gateway to the river valley's great history, the blending of cultures and a host of recreational options to all who journey it for three-quarters of a century and counting.

### Rep. Ron Kind (WIS) proclaims Great River Road 75th Anniversary in US House of Representatives, text follows:

I rise before you today to celebrate the 75th anniversary of the Great River Road; one of our Nation's most historic and extensive scenic byways.

Spanning nearly 3,000 miles from Canada to the Gulf of Mexico, the Great River Road traces its origins back to a time when Franklin Roosevelt was President and the automatic transmission was the cutting edge of automotive technology. In 1938, governors from 10 States came together to form the planning commission for what was initially envisioned as a continuous national parkway extending along the entire length of the Mississippi River. Over the next two years the U.S House of Representatives Committee on Public Lands held hearings to authorize a feasibility study of the parkway concept. While popular, the idea was soon overshadowed in the wake of the Second World War.

More than a decade passed before a feasibility study was finally completed by the Bureau of Public Roads in 1951. Finding the construction of an entirely new parkway to be too expensive, the study offered an alternative proposition; the development of a scenic route built from the existing network of rural roads and highways that meandered and crisscrossed the Mississippi River. This route, now known as the Great River Road, is a testament to the cooperative effort of States and the Federal Government working together with local communities to preserve the many historic features and

natural beauties of the Mississippi River Valley.

Today the Great River Road offers travelers not just a leisurely scenic drive but a unique and lasting journey through diverse communities and landscapes; from charming river towns to lush forests, from bluffs to the delta, from big city to sprawling rural vistas. The Great River Road is truly a national treasure. It is with great pride that I rise today to commemorate the 75 years of hard work and dedication that have gone into developing and preserving the Greater River Road so that it will continue to serve as a gateway to the rich heritage of the Mississippi River for future generations.

The ideas exchanged included continued effective dust control on the gravel road from the landing to the Great River

Road, improved signage to direct and welcome visitors to lowa, benches, updated information on the existing kiosk, and a marketing campaign to "Welcome ferry travelers to the wild side of lowa."

The Iowa MRPC will continue to communicate with Cassville Harbor Commissioners about working together to move the ideas forward.
