


Highway 150 Coalition

Our Mission

The Highway 150 Coalition is determined to bring improvements to the transportation issues along Highway 150, specifically within the City of Independence, a critical point along Highway 150.



What North East Iowa Needs

- The IA 150 Coalition envisions an efficient and safe corridor as the North/South corridor serving all North East Iowa to I-380 and Minnesota.
- We ask to work with the lowa DOT to determine solutions for operational needs along the corridor.



Study Needed

- A study is needed for the entire corridor to alleviate
 - Safety and congestion concerns in Independence
 - Narrow and steep shoulders
 - Higher truck traffic between Oelwein and Independence
 - Shadowing at intersections, especially near Oelwein and Decorah
 - Planning for future expansion of the communities along 150

Committed

- \$100,000 in Regional Planning Agency funding is programmed for a Planning Study of IA Hwy 150
- FY 2022 (October 1, 2021).



Progress To Date


- Independence has been awarded a Traffic Engineering Assistance Program (TEAP)
 - provides traffic engineering expertise to local units of government
 - identify cost-effective traffic safety and operational improvements through a congested section of Independence
- Shoulder widening on 150 for maintenance, safety and bicycle traffic
 - West Union to Calmar will see 6-foot paved shoulders with rumble strips, an improvement for drivers and riders

Independence Bottleneck


Independence is a crucial point for Highway 150, and the safety and congestion issues in Independence needs to be addressed.

150 in Independence turning east into the downtown


Freight Bottleneck
