COMPLIMENTARY ROUNDABOUT DESIGN REVIEW SERVICE

Background

Small localities in lowa do not necessarily have the resources to staff a full-time traffic engineer dedicated to analysis and design of intersection safety enhancement projects, including roundabouts.

The Iowa Department of Transportation (DOT) created an innovative program—the Traffic Engineering Assistance Program (TEAP)—to deliver this very service to help smaller jurisdictions by providing an "expert onhand," who visits the jurisdiction, gathers input from local stakeholders, and makes recommendations to help the agency identify, analyze, and implement traffic safety improvements.

In 2004, Iowa DOT expanded its expert-on-hand repertoire to include roundabout analysis, design, and out-reach support. They implemented this expansion in response to frequent questions about roundabout feasibility, how to design a roundabout effectively, and how to generate support from the local community.

lowa Traffic Engineering Assistance Program (TEAP)

TEAP provides traffic engineering expertise to local units of government. The purpose is to identify cost-effective traffic safety and operational improvements as well as potential funding sources to implement the recommendations. Typical studies include high-crash locations, unique lane configurations, obsolete traffic control devices, school pedestrians, truck routes, parking issues, and other traffic studies.

lowa DOT provides this free Roundabout Design Review service to municipalities throughout Iowa on an on-going basis.
