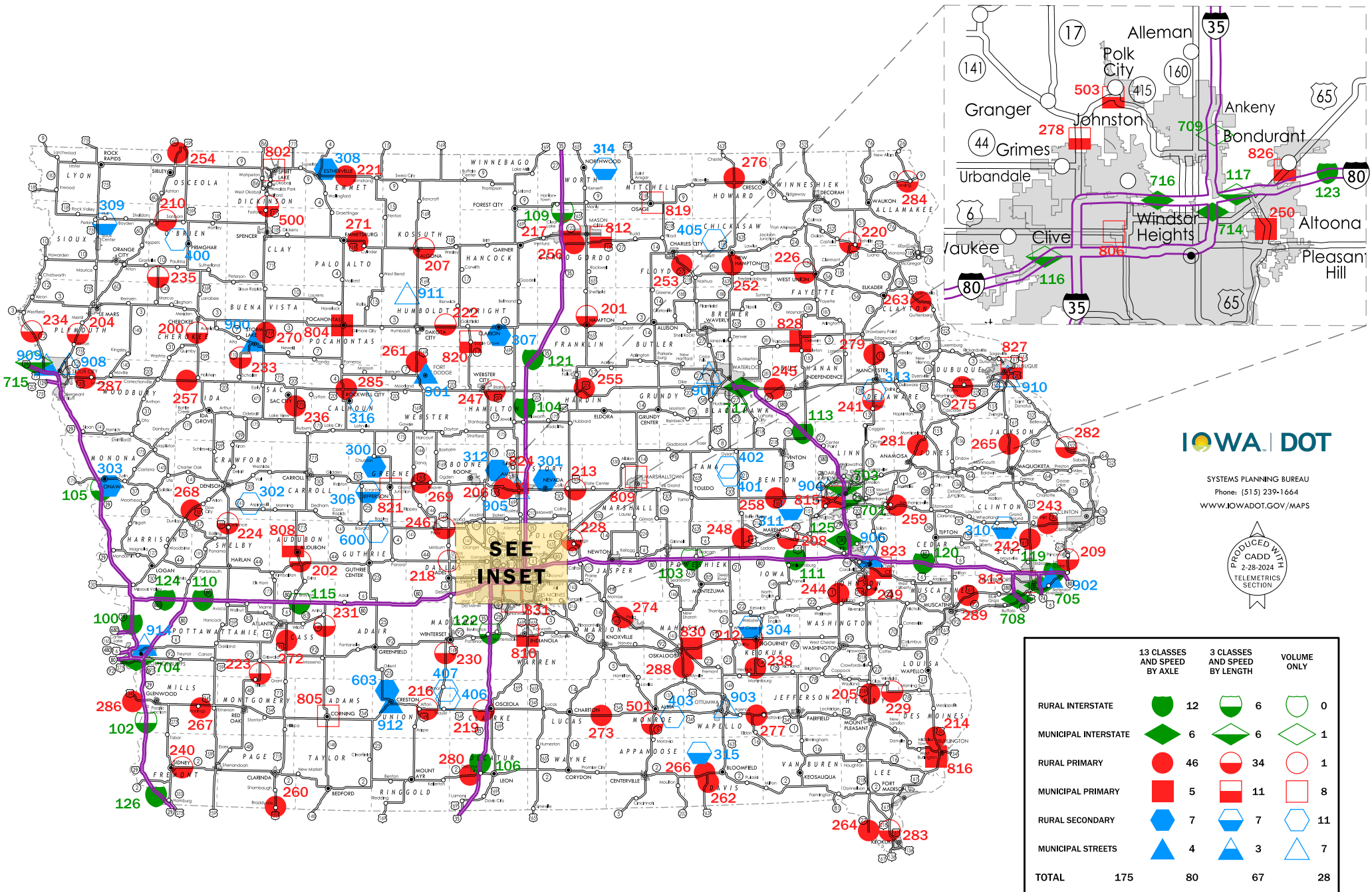
Data collected at the 176 continuous automatic traffic recorder locations shown on the following pages were utilized to compute the above percentages.

Data are used to estimate the percent change in monthly traffic compared with the same month in the previous year. Estimates are reconciled annually to match the vehicle miles of travel from the Highway Performance Monitoring System.

The rural, municipal and state totals were weighted based on estimated vehicle miles of travel.

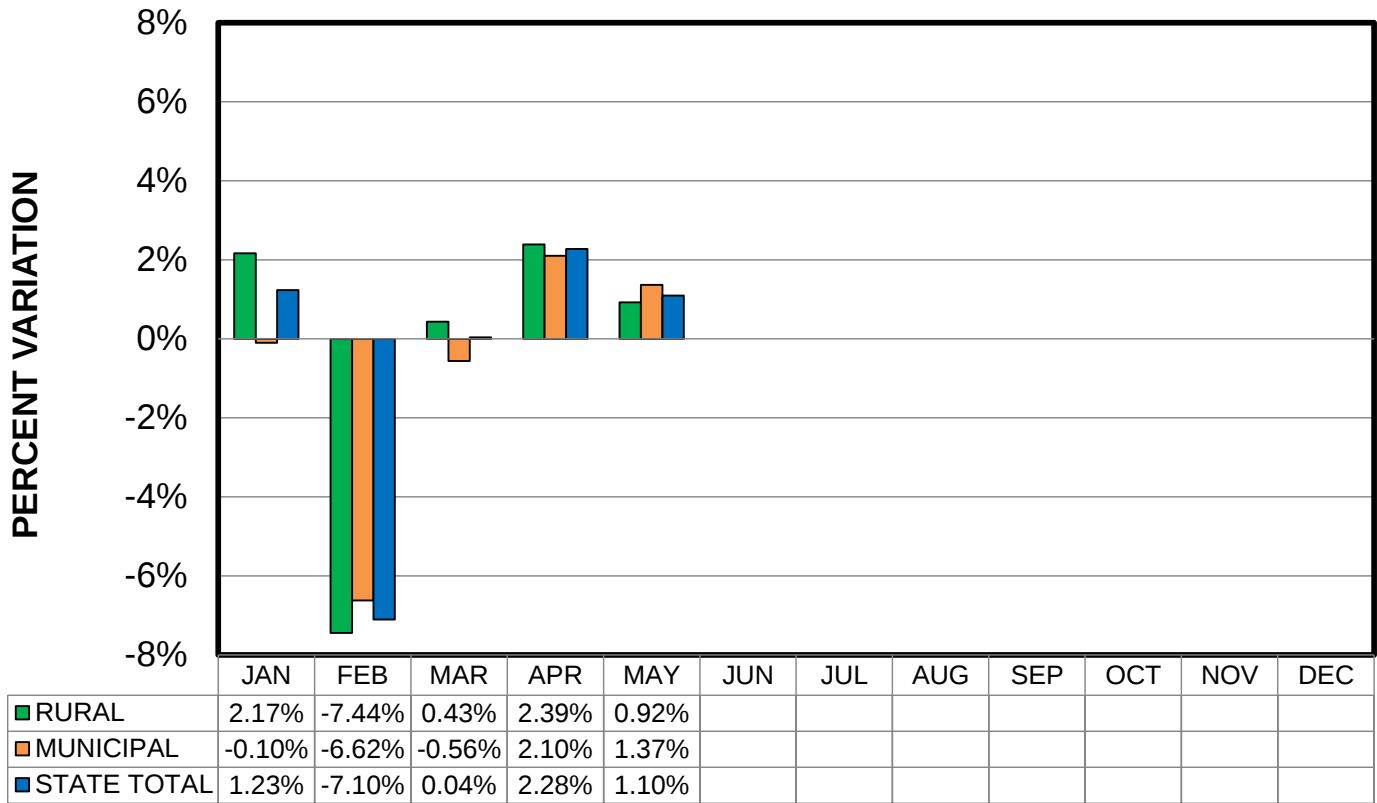

January 1, 2025



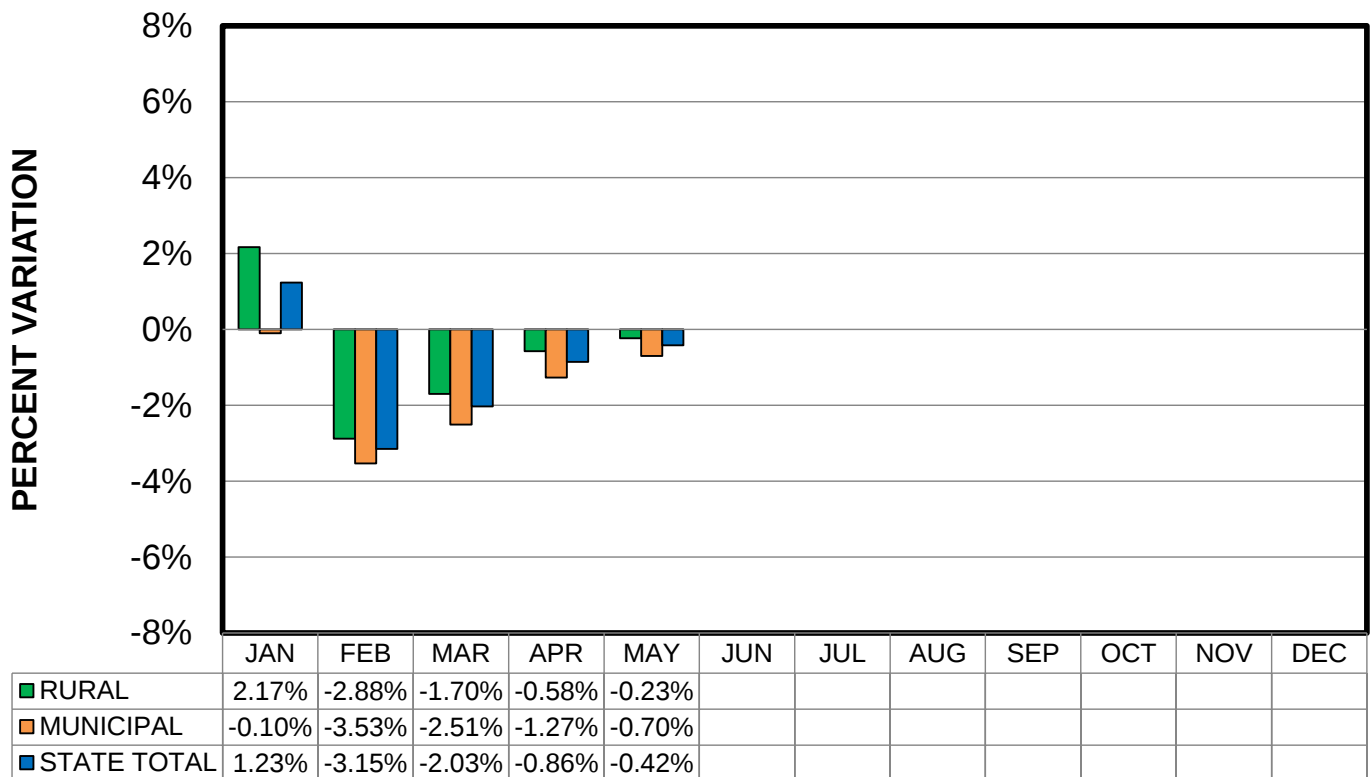
MONTHLY TRAFFIC VARIATIONS

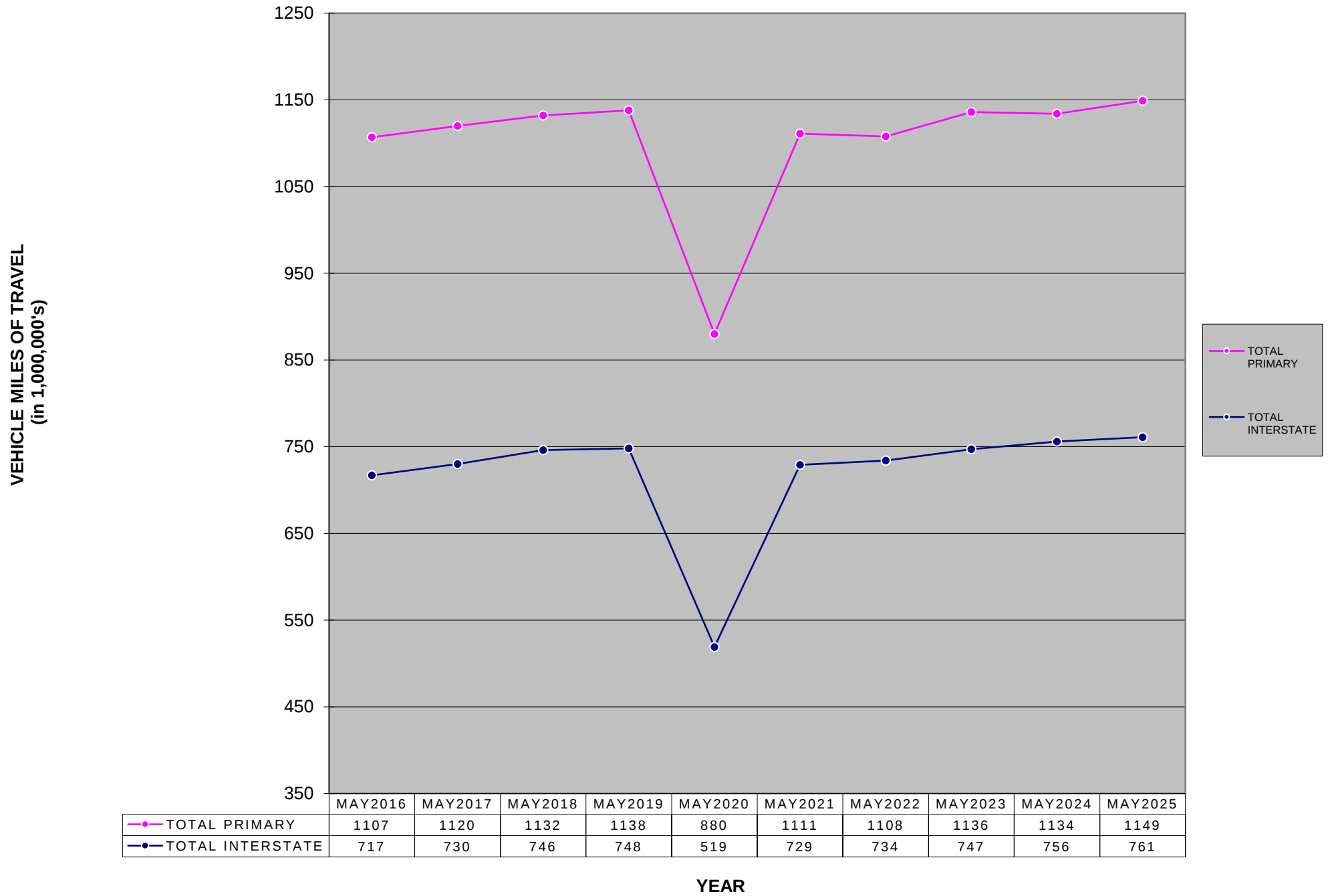

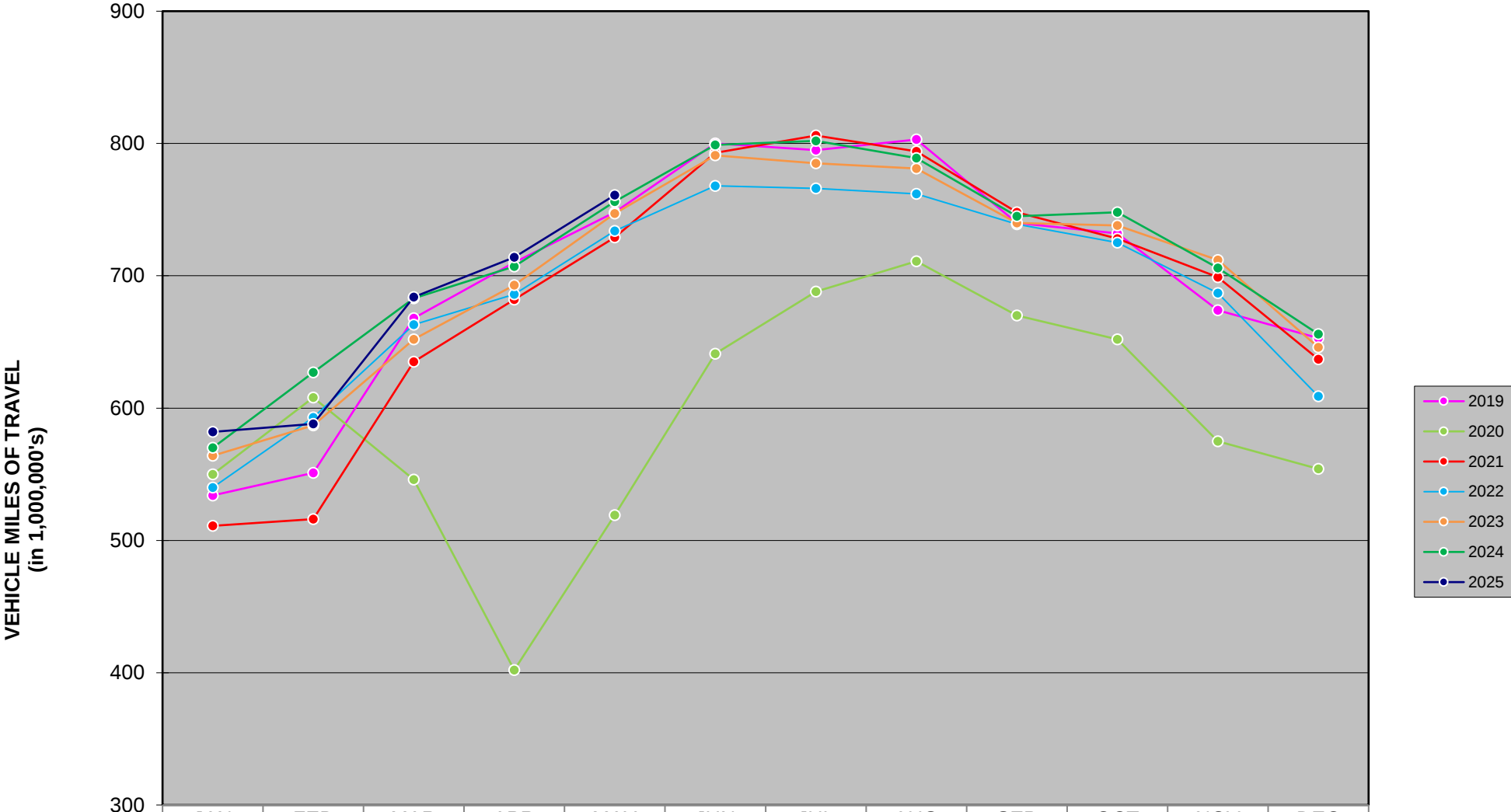

MAY HISTORICAL VMT



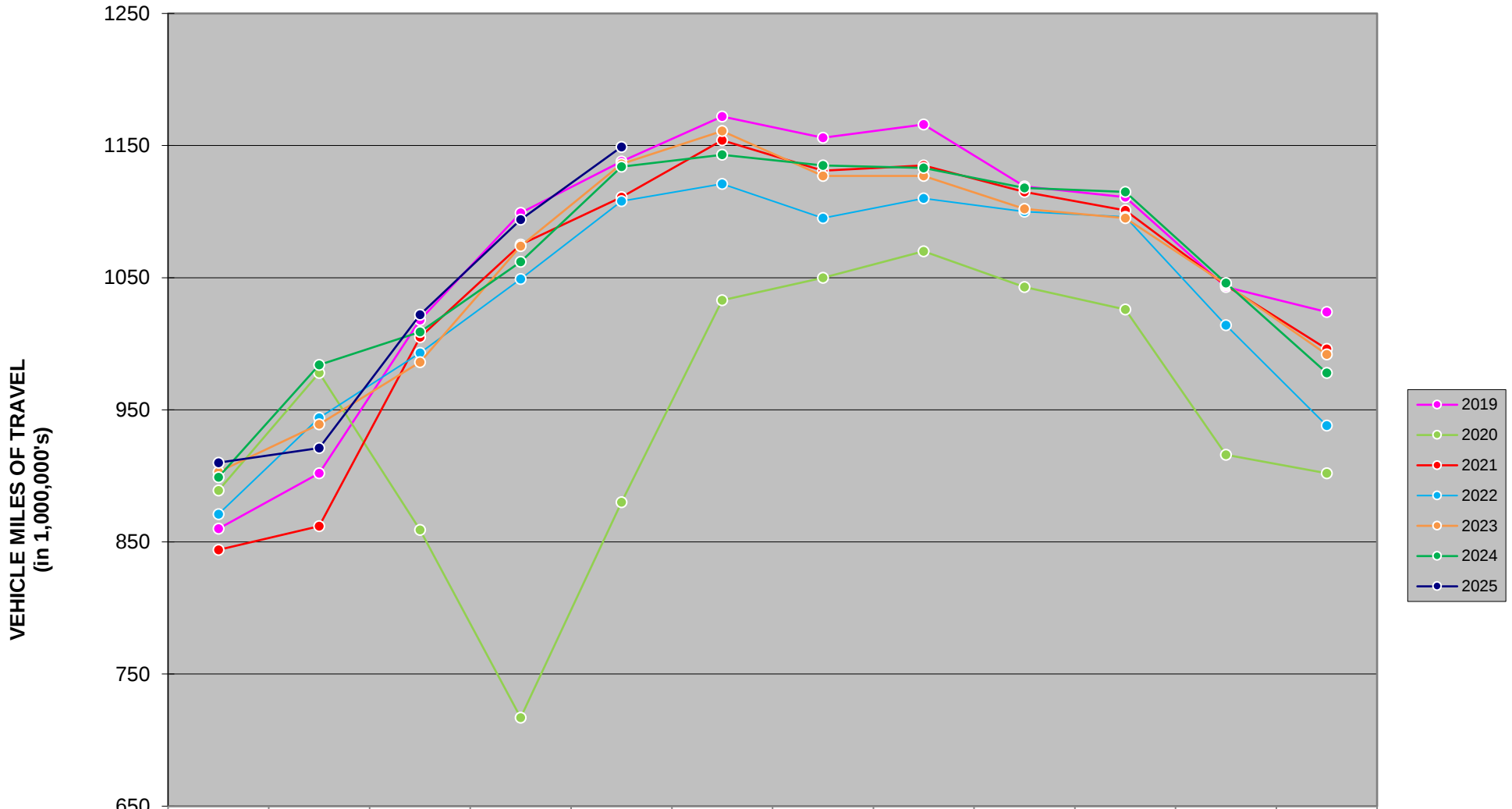

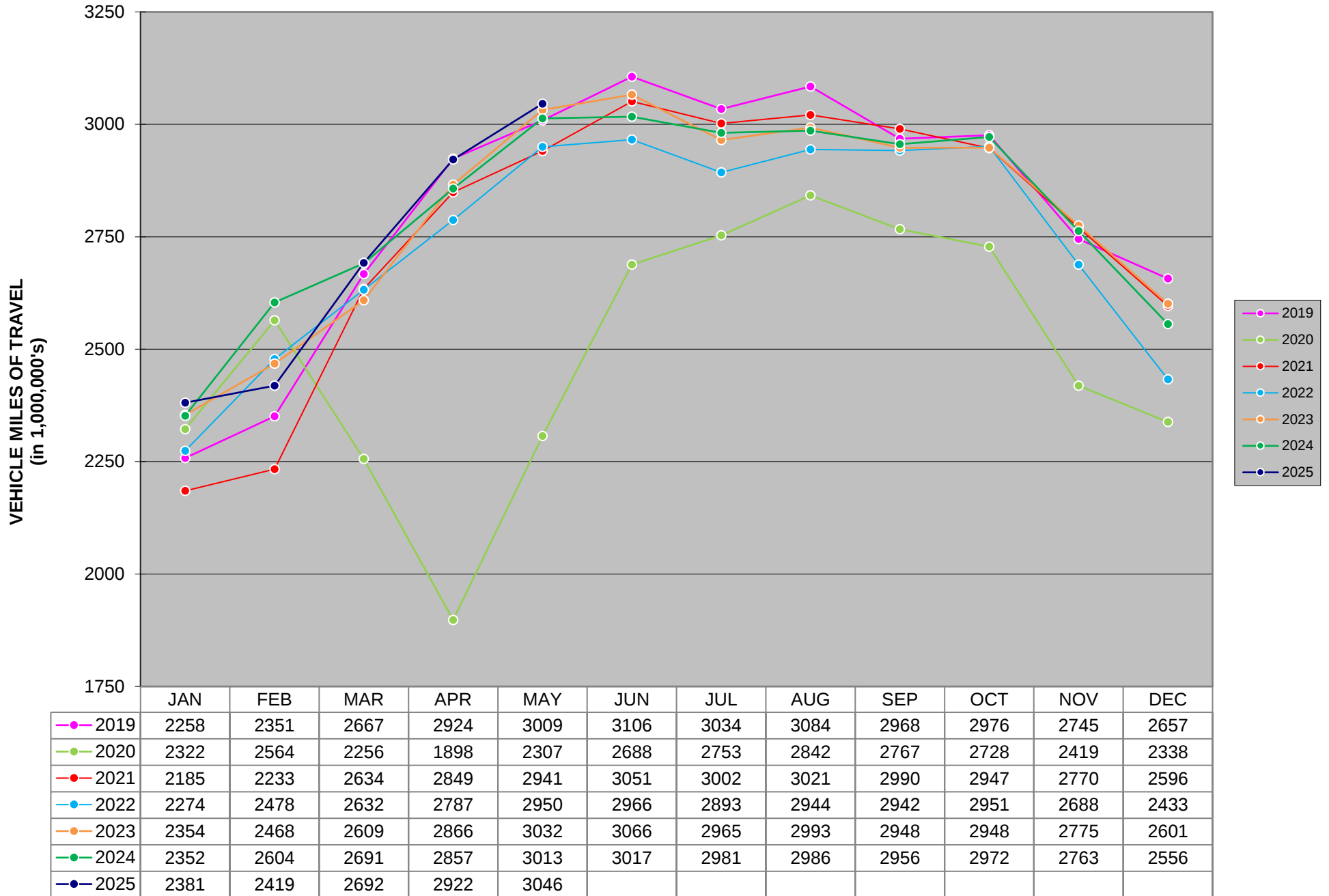
