



Statewide Transportation Alternatives Set-Aside Program

- Current version of program in existence since 1991
- Majority of funding is distributed to Iowa's MPOs and RPAs, but \$5 million reserved for statewide projects annually with 20% target for Safe Routes to School projects
- Available to a variety of project sponsors but most applicants are cities and counties



Eligible Activities

- On-road and off-road non-motorized trail facilities, safe routes for non-drivers, conversion of abandoned rail corridors for trails, preservation/rehabilitation of historic transportation facilities among others
- Federal Recreational Trails Program eligible activities
- Infrastructure-related or non-infrastructure related Safe Routes to School Projects
- Scenic Byways





Iowa River's Edge Trail Bridges & Great American Rail Trail Connector (Marshalltown)

This project rehabilitates three and replaces one existing rail bridge providing a safe 2.7 mile unimproved segment of the lowa River's Edge Trail north to Albion & constructs a 0.3-mile trail connection to the Linn Creek Greenbelt Trail in Marshalltown.

Total Cost: \$3,353,000

Requested: \$2,000,000 (60%)

Waukee Regional Trail Connection & Safety Improvements Project (Waukee)

This project will construct 0.84 mile of trail between the Raccoon River Valley Trail and the Heart of the Warrior Trail including trail underpasses at U.S. 6 and NW 10th Street in Waukee.

Total Cost: \$5,588,000

Requested: \$2,000,000 (36%)





Emmons Street Pedestrian Bridge over I-380 (Hiawatha)

The project will construct 400foot of trail and a pedestrian trail bridge over I-380 connecting the Emmons Street Trail and Guthridge Park and providing a route for west Hiawatha to access the 52-mile Cedar Valley Nature Trail.

Total Cost: \$1,056,000

Requested: \$792,000 (75%)

Duck Creek Trail Underpass at Division Street (Davenport)

This project will replace an atgrade crossing on a four-lane arterial roadway with a 425-foot trail underpass of Duck Creek Trail at Division Street.

Total Cost: \$256,500

Requested: \$205,200 (80%)





This project will pave 3.6 miles of the Iowa River's Edge Trail from Gifford to Union to create a nearly 14-mile continuous paved trail south from Steamboat Rock.

Requested: \$1,185,600 (80%)
