INTRODUCTIONS

A PDF version of this report is also available at https://iowadot.gov/analytics/roadway-asset-management-system/secondary-road-miles. The lowa Department of Transportation's (lowa DOT) Analytics Bureau is responsible for preparing this secondary road report. The report provides federal, state and local agencies, and the public with statistical information regarding the secondary road system.

Information for this report is derived from data reported by each of the 99 lowa county engineer offices. Based on these construction reports, which may have changed the road surface, length and functional classification, the lowa DOT's database is updated and current as of Jan. 1, 2025.

The report contains three major sections: state totals in miles by type of surface, a statistical summary and county statistical summaries.
