What is the intended benefit of the rule?

To provide advanced allocation of state transit assistance dollars to public transit systems to assist with their monthly cash flow.

Is the benefit being achieved? Please provide evidence.

Yes. All of Iowa's public transit agencies opt for advanced allocations of state transit assistance funding. For federal transit dollars, the transit agencies must submit reimbursement requests after the services have been provided, which can put a strain on cash flow. While typically a smaller amount of funding than the federal transit dollars, the advancement of state transit assistance funds has helped transit agencies cover payroll and over other expenses while awaiting reimbursement of federal funds.
