Problem Statement

The use of positive protection measures between the work space and motorized traffic can improve work zone safety for all users. However, evaluation of various combinations of measures and strategies within the positive protection umbrella is needed for State DOTs to appropriately understand and maximize a positive protection plan appropriate for each work zone.

Objectives

The primary objective of this research project is to develop a structured, data-driven, decision support tool to assist engineers in using a defined set of positive protection measures in highway work zones. The project should, at a minimum, determine what constitutes a positive protection measure. It should also consider a variety of approaches and the various factors that may influence the comparison and choice of particular measures. These factors should include but not be limited to work zone duration, operational mode (i.e., stationary, mobile, or moving), traffic flow characteristics and impacts, length of the construction zone, geometrics, and the proximity of workers to active traffic lanes. A benefit/cost analysis should also be considered as part of the decision support tool developed. The data used in the creation of the tool may come from a variety of sources and the decision tool should include a consideration of the entire life span and/or stages of the construction work zone. Finally, the project tasks should also consider all the decision-making tools/matrices and resources that already exist in this subject area and are being applied within the United States. It is expected that the tool developed as part of this project will build upon and improve upon those that currently exist. In addition, all the recently added requirements for positive protection in 23 CFR 630 subpart K (Temporary Traffic Control Devices) must also be considered.

• **Proposal Restrictions**

- Proposals are limited to 8 pages. Resumes of the principal investigator and other named team members, along with other relevant materials, may be provided for additional information in appendices, but the proposal itself shall be a stand-alone document. The proposer should not expect the reviewers to read appendices to be able to evaluate the merit of a proposal.
- The proposing entity must be a college or university located in one of the states pledging funds to the SWZDI TPF-5(545) pooled fund: Alaska, Georgia, Illinois, Iowa, Kansas, Michigan, Minnesota, Missouri, Nebraska, Pennsylvania, Texas, or Wisconsin. The principal investigator and any co-principal investigator(s) must be a faculty or professional staff employed by the proposing entity.
- Proposals submitted by current SWZDI principal investigators that have projects one year or more behind their originally contracted end date will not be considered.
- o Individual respondents are limited to submitting on only one SWZDI proposal per year as either a principal investigator or co-principal investigator.
