Funding Recommendation



Federal Recreational Trail Program

- Created in 1991
- Available to federal, state, and local government agencies. Private individuals and organizations may apply with a government co-sponsor.
- Purpose is to develop and maintain recreational trails and trail related facilities for both motorized and non-motorized trail users.
- Eligible projects include:
 - Maintenance and restoration of existing trails, development of trailside and trailhead facilities, purchase of trail construction and maintenance equipment, construction of new trails and acquisition of land for trails.

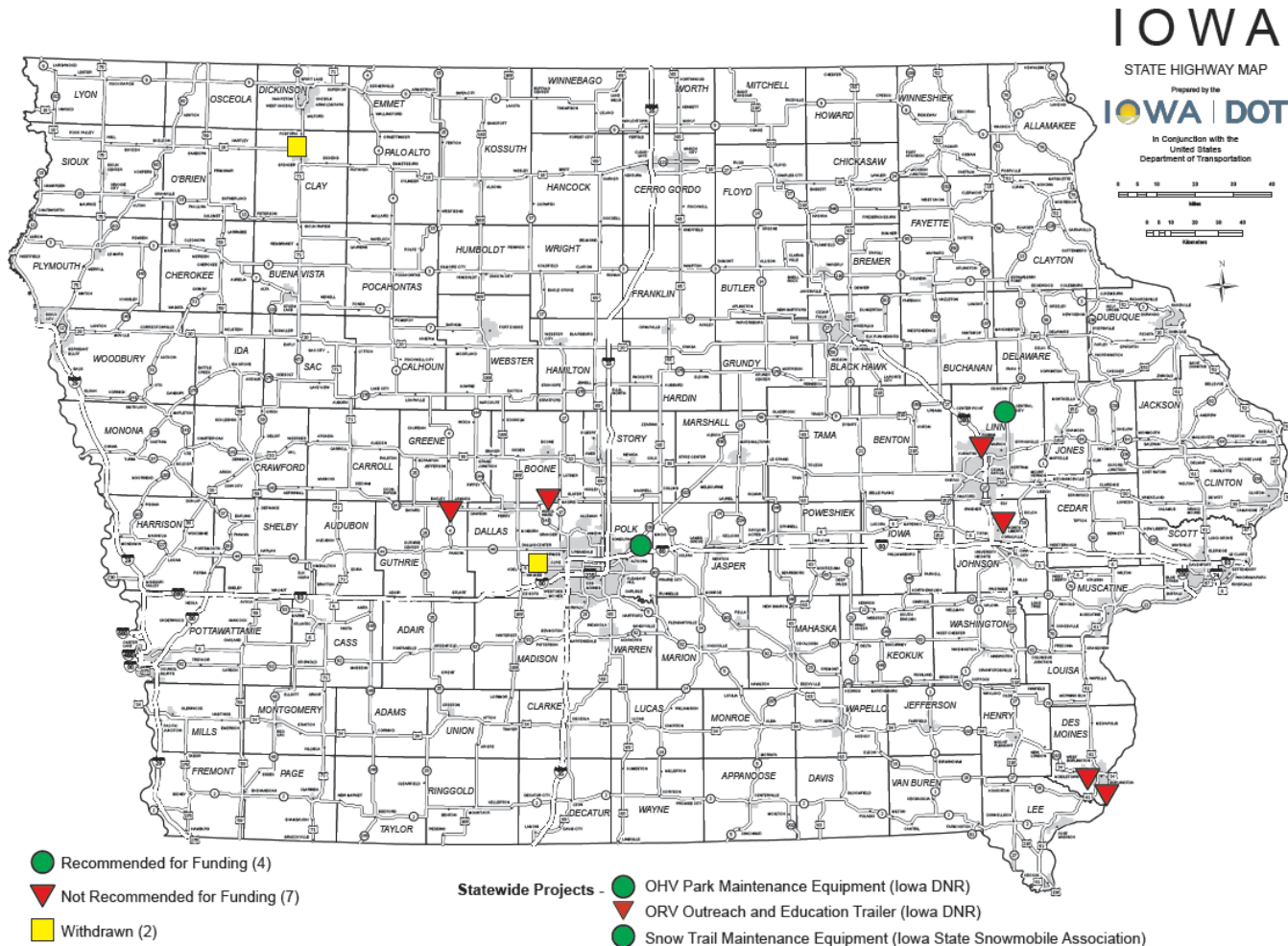

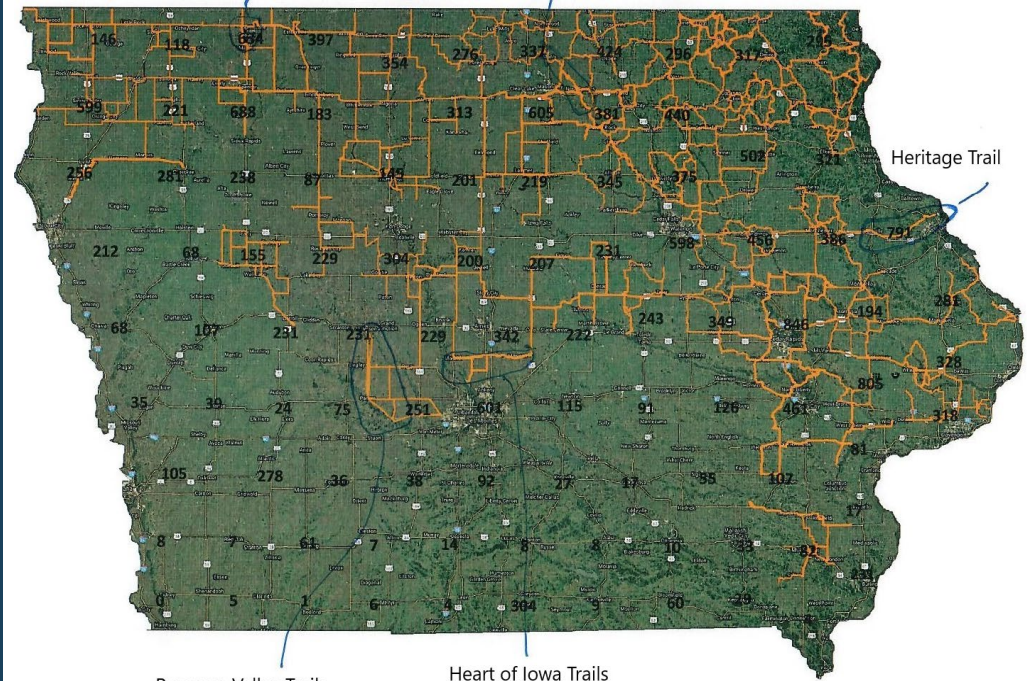

Total Cost: \$330,000

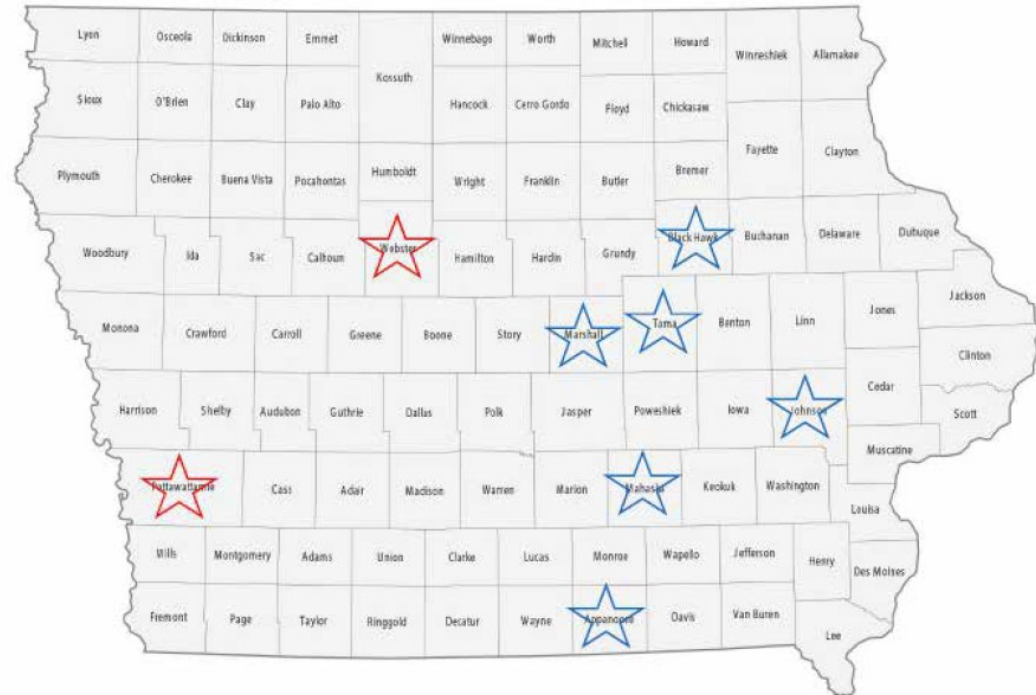

Parks assisted by this request in blue



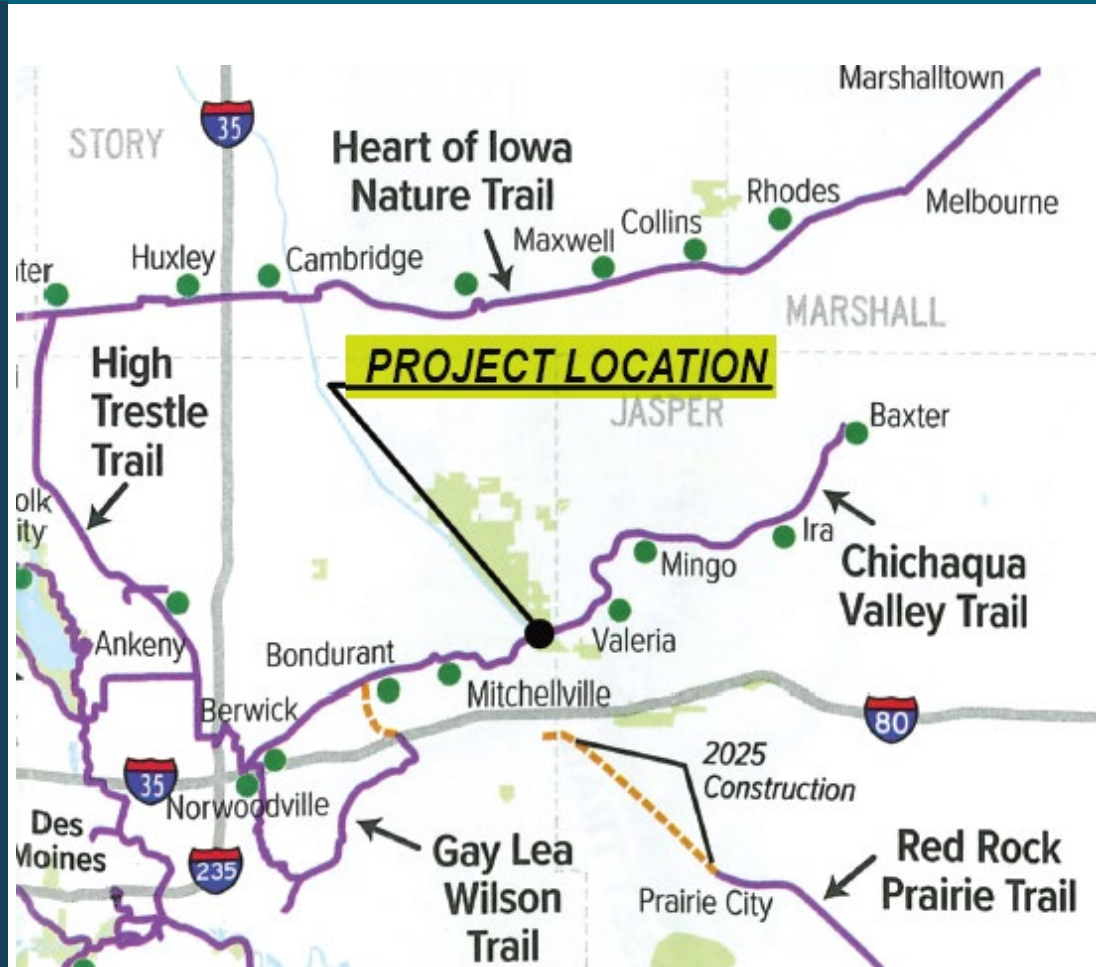

Skunk River Bridge Repair (Polk County Conservation Board)

Provides structural repairs and replaces existing wood decking with concrete on 100-year-old, 453-foot timber bridge located northeast of Mitchellville on the Chichaqua Valley Trail. The 26-mile Chichaqua Valley Trail is located on the former Chicago Pacific Railroad corridor between Berwick and Baxter.

Total Cost: \$885,000

Requested: \$468,000 (53%)

Pinicon Ridge Park Wapsi Bluff Trail Connector (Linn County Conservation Board)

Constructs 0.75 mile of paved trail in two sections within the 1,018-acre Pinicon Ridge Park and is part of a 3-mile loop trail that connects Pinicon Ridge Park with Central City.

Total Cost: \$460,000

Requested: \$325,000 (71%)
