Title Revitalize Iowa's Sound Economy (RISE) Application – Altoona

DISCUSSION/BACKGROUND:

The city of Altoona submitted a RISE Local Development application in the September 2025 round requesting a grant to assist in construction of approximately 1,085 feet of 33rd Street NW and intersection improvements including turn lanes along 34th Avenue NW at 42nd Street NW, 33rd Street NW and 25th Street NW with a traffic signal at 25th Street NW located on the northwest side of town.

This project is necessary to provide improved access to four lots totaling more than 216 acres for industrial purposes. This project is anticipated to be completed by September 2027.

The evaluation and rating for the project will be discussed.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the Commission, based on the capital investment commitment and potential for future job creation, award a RISE grant of \$2,402,703 from the city share of the RISE Fund and \$318,578 from the county share of the RISE Fund for a total of \$2,721,281 or up to 50 percent of the total RISE-eligible project cost, whichever is less.

The City of Altoona submitted a RISE Local Development funding request to assist in construction of approximately 1,085 feet of 33rd Street NW and intersection improvements including turn lanes along 34th Avenue NW at 42nd Street NW, 33rd Street NW and 25th Street NW with a traffic signal at 25th Street NW located on the northwest side of town.

This project is necessary to provide improved access to 4 lots totaling approximately 216 acres for industrial purposes.

Under our RISE Local Development criteria, this project received a rating of 43 points and is anticipated to be completed by September 2027.

The total estimated cost of the project is \$5,442,562. The City of Altoona has requested a RISE grant of \$2,721,281 or up to 50 percent of RISE-eligible project costs.

It is recommended the Commission, based on the capital investment commitment and potential for future job creation, award a RISE grant of \$2,402,703 from the city share of the RISE Fund and \$318,578 from the county share of the RISE Fund for a total of \$2,721,281 or up to 50 percent of the total RISE-eligible project cost, whichever is less.
