FEDERAL COMPETITIVE GRANTS

▪ Application Phase:

- An LPA shall inform the Local Systems Bureau of their intent to submit a grant application.
- LPA shall provide a summary of the application, along with a project timeline and intended funding match.
- If this step is not completed, the Iowa DOT will not serve as a pass-through

▪ Award Phase:

- If the steps on the left have been completed, the Iowa DOT reserves the right to choose to be a pass through. FHWA always initially assumes Direct Recipient.
- There are benefits to both pass-through and Direct Recipient.
- LPA must submit to Iowa DOT Local Systems Bureau, a project timeline, so Iowa DOT can assess whether we think the timeline is reasonable and achievable
- Sometimes, time frames listed in grant applications are more optimistic than realistic. If so, the Iowa DOT may not be able to serve in a pass-through role, as the DOT can't take on risks that the project will not make its milestones.
- We have guidelines, deadlines, and rules in place for various reasons; all our I.M.s and procedures have been vetted through FHWA and follow Federal and State laws and regulations.
- Our deadlines listed in our I.M.s are requirements and are considered to be minimums.

COMPETITIVE GRANT PROGRAMS

TIGER/BUILD/RAISE:

- Established in 2009 as TIGER
- BUILD FY26 NOFO released on 12/15/25
- Applications are due on 2/24/26
- Maximum award \$25M
- Minimum award \$1M for rural and \$5M for urban
- Obligation Deadline 9/30/30 and Expenditure Deadline 9/30/35

COMPETITIVE GRANT PROGRAMS

BIP:

- Established in 2022, three project types: Large Bridge, Planning, and Bridge
- BIP FY26 Planning and Bridge NOFOs are under review and have not been released
- BIP FY26 Large Bridge applications were due 8/1/25, awards have not been made
- Large Bridge projects have total eligible project costs over \$100M
- Planning projects are awarded at 80 percent of the total eligible project costs
- Bridge projects have total eligible project costs under \$100M

COMPETITIVE GRANT PROGRAMS



U.S. Department of Transportation

SS4A:

- Established in 2022, LPA's must be a direct recipient for this program
- Applicants must have an eligible Action Plan to apply for an implementation grant
- SS4A FY26 NOFO has not been announced
- FY25 NOFO closed on 6/26/25, watch for a spring release of FY26 NOFO
- Congrats to all awardees from the FY25 round of funding

COMPETITIVE GRANT PROGRAMS



U.S. Department of Transportation

PROTECT:

- Established in 2022
- PROTECT FY26 NOFO is under review and has not been released
- Applications are due on 2/24/26
- The deadline for applications has been in late February the past two rounds of funding

COMPETITIVE GRANT PROGRAMS

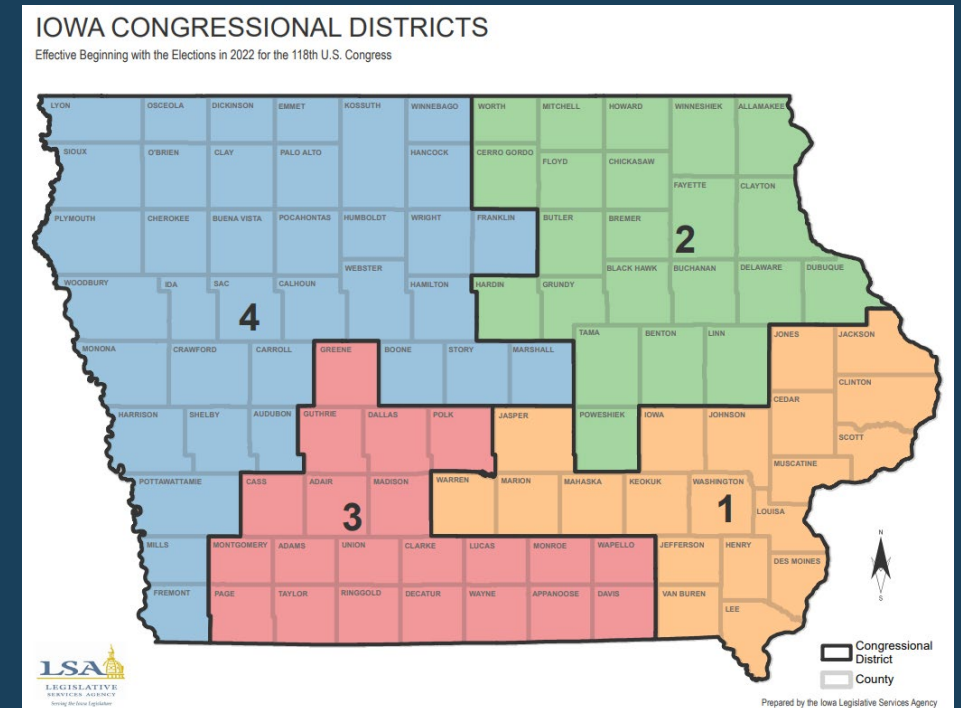
CHBP:

- Established in 2018, State DOTs must be the applicant
- Iowa is one of four states to receive no less than \$32.5M per funding round
- CHBP FY24 and FY25 applications have been submitted with 67 total projects
- Awards have not been made, potential announcement this Spring
- FY24 Obligation Deadline 9/30/27 and Expenditure Deadline 9/30/32
- FY25 Obligation Deadline 9/30/28 and Expenditure Deadline 9/30/33

FEDERAL EARMARKS

- Also known as **Community Project Funding (CPF)**
- Check on your Congressional representative's webpage for when and if they are taking applications for their CPF (Max of 15 projects per congressional district)
- Awards will depend on how much is available, subject to federal allowance per federal appropriations bills
- The appropriation bill Congress approved in FY25 did not include funding for Earmarks. However, there is funding included in FY26.

TIPS



- Be sure to attend Federal aid training if you are intending to work with Competitive Grants.
- Consider Project Development timelines compared to the Obligation Date in the Grant NOFO when applying.
- If the total Grant Award will not cover the federal share of construction, please do not use Grant funds to fund PE/CE.
Ex. Construction costs are \$1M and Grant is \$500,000

TIPS



- Review the programmed funding when a Grant is awarded and adjust programmed years, as necessary.
- Review the planned letting schedule from the Grant Application, and if there are changes to the schedule be sure to draft the Grant Agreement with the changes.
- Don't pay for materials in construction that don't have certifications to avoid costs becoming nonparticipating.
- Review BABA requirements during Project Development. Compliance before construction begins will save project costs.

PROJECTS



- All active Competitive Grants in Iowa total approximately \$270M, with the projects having an estimated \$370M in construction funds
- FY22-Fy24 Earmarks total \$75M in federal funding
- There are currently 32 contracts in progress (Planning/Construction)
- The FY24 & FY25 CHBP applications will add 67 Projects and \$65M in Competitive Grant funding.
