

1933

- President Hoover signed the Buy American Act into law.
- Required federal agencies to procure domestic materials & products
- Applied only to direct federal procurement
 - Did NOT apply to contracts awarded by State & local authorities under Federal grant programs, such as the Federal-aid program w/ FHWA
- All goods: articles, materials, or supplies



1970's



Imported steel become easier to access & cheaper than U.S. steel

Surface Transportation Assistance Act (STAA)

Congress expanded domestic preference to other fed programs

23 USC 313 – Buy America

23 CFR 635.410 – Buy America Requirements

Infrastructure Investment and Jobs Act (IIJA)

Introduced the Build America, Buy America (BABA) Act

- Expanded domestic procurement requirements beyond iron and steel
- Required FHWA reevaluate nationwide waiver for Manufactured Products
- Provided a framework and guidance for materials that need to be domestically sourced



BABA OVERVIEW

- IIJA established new **Domestic Materials Procurement Requirements** for all infrastructure projects receiving Federal financial assistance.
- No federal financial assistance may be obligated for a project unless:
 - All iron and steel used in the project are produced in the United States
 - The manufactured products used in the project are produced in the United States
 - The construction materials used in the project are produced in the United States.

IRON AND STEEL



- **Articles, materials, or supplies that consist wholly or predominantly of iron and steel.**
- **Predominately means... costs exceed 50% of total cost of all components.**
- **Includes protective coatings**

CONSTRUCTION MATERIALS

New Items in 2023 (2 CFR 184)

- Non-ferrous metals
- Plastic and polymer-based products
- Glass
- Fiber-optic cable
- Optical fiber
- Lumber
- Engineered Wood
- Drywall



MANUFACTURED PRODUCTS

- A manufactured product is defined as an article, material, or supply that has been processed into a specific form and shape, or combined with other articles, materials, or supplies to create a product with different properties than the individual articles, materials, or supplies.
- If, however, an article, material, or supply meets this definition but could also be classified as an iron or steel product, excluded material, or other product category as specified by law or in 2 CFR part 184, that article, material, or supply is not a manufactured product.

MANUFACTURED PRODUCTS

Nationwide waiver terminated 1/14/25

- Manufactured products must now comply with the BABA requirements.



Starting with the October 2025 letting...


- Final assembly must occur in the U.S.



Starting with the October 2026 letting...

- Final assembly must occur in the U.S.
- 55% of cost of components must be from U.S.

EXCLUDED ITEMS



- Cement and cementitious materials
- Aggregate such as stone, sand, or gravel
- Aggregate binding agents or additives
- Asphalt

PRECAST AND ITS

- Every item on the project will fall under one of these four categories. EXCEPT:

- Precast items

- Classified as Manufactured Products.
- Any iron/steel must also follow existing requirements.

- ITS Components

- Classified as Manufactured Products
- Any iron/steel enclosures must also follow existing requirements.

BUILD AMERICA, BUY AMERICA

GENERAL

This IM is intended to provide additional instruction to Buy America, (see <https://www.gpo.gov/fdsys/pkg/CFR-2013-title23-vol1/xml/CFR-2013-title23-vol1-sec635-410.xml>), and Build America, Buy America (BABA) requirements under the Infrastructure Investment and Jobs Act (IIJA) (see <https://www.ecfr.gov/current/title-2/part-184>) and Standard Specification [1107.06](#).

With the exception of the excluded items listed below, the IIJA requires the following three BABA preferences. An article, material, or supply shall only be classified into one of these categories, and not multiple categories.

1. Products of Iron and Steel

Iron or steel products means articles, materials, or supplies that consist wholly or predominately of iron or steel or a combination of both.

All iron and steel permanently incorporated into the project must be produced in the United States, including all manufacturing processes, from the initial melting stage through the application of coatings.

The contractor shall order with a domestic preference and submit a Certificate of Buy America Compliance Iron and Steel, IM 107 Appendix B, or an approved alternate, from the producer/supplier certifying all construction materials are in compliance with Buy America. The Contractor shall submit all product specific information identified in the pertinent IM. Additional documentation shall be made available to the Engineer upon request.

The following lists of Iron and Steel products, at a minimum, are subject to Build America requirements.

WAIVERS – DE-MINIMIS

- Construction Materials & Manufactured Products
 - BABA requirements are waived if the total value of the non-compliant products is no more than the lesser of \$1,000,000 or 5% of the total applicable costs for the project.*
 - *This does not apply to iron or steel. See next bullet.
- Iron and Steel
 - A minimal use of foreign steel or iron products may be used, if the cost of such materials does not exceed 0.1% of the total contract cost, or \$2,500, whichever is greater. (23 CFR 635.410)

WAIVERS – SMALL GRANTS

- **BABA requirements are waived** when the total Federal Financial Assistance provided to a project is **below \$500,000**.
 - **Includes total scope of work within NEPA document**
- LPA must request this from the Iowa DOT (not automatic).
- See I.M. 3.740 for more details (it's only one page!)

WAIVERS – PROJECT SPECIFIC

- These types of waivers are very rare, but they may be granted if:
 - The application of BABA provisions are inconsistent with the public interest.
 - Materials are not produced in the U.S. in sufficient and reasonable available quantities which are of satisfactory quality.

- Begin this process early in project development!



NEXT STEPS

- Be familiar with the new requirements that took effect in October 2025
 - Manufactured Products
 - New forms in IM 107 Appendix A and B, available via the ERL
- Project Development:
 - Ensure design elements are BABA compliant, especially if sole-sourcing or using 2599 bid items and Special Provisions.
 - Understand the waiver process.
- Construction:
 - Ensure proper certifications are received / exemptions are documented.


