Title Revitalize Iowa's Sound Economy (RISE) Application – Waterloo						

DISCUSSION/BACKGROUND:

The city of Waterloo submitted a RISE Immediate Opportunity application requesting a grant to assist in replacement of the 11th Street Bridge located in the center of town. This project is anticipated to be completed by December 2023.

Because this project will provide improved access to more than 23 acres for industrial purposes and to maximize RISE support for this project, staff evaluated the application as a RISE Local Development project.

The evaluation and rating for the project will be discussed.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the Commission, based on the capital investment commitment and potential for future job creation, reclassify the project as a RISE Local Development project in the February 2021 round of applications and award a RISE grant of \$1,723,952 or up to 50 percent of the total RISE-eligible project cost, whichever is less, from the city share of the RISE Fund.

Craig Markley, Transportation Development, Systems Planning Bureau; Waterloo submitted an Immediate Opportunity funding request to replace the 11th Street bridge, located in the center of town. This project will provide improved access to the 23 acres for industrial purposes. To maximize RISE support for this project, staff evaluated the application as a RISE Local Development project. Under RISE Local Development criteria the project score of 66 points. Total estimated cost of the project is \$8,923,952. The city is requesting a RISE grant of a \$1,723,952 and providing the local match.

It is recommended the Commission, based on the capital investment commitment and potential for future job creation reclassify the project, to a RISE Local Development project in the February, 2021 round of applications and award a RISE grant of \$1,723,952 or up to 50% of the total RISE eligible project cost, whichever is less. Funding would come from the city share of the RISE fund.

Commissioner Yanney made a motion to reclassify the project as RISE Local Development project and award the RISE grant for Waterloo. Commissioner Rielly seconded the motion. Motion passes unanimously.

DISCUSSION/BACKGROUND:

The city of Des Moines and the Des Moines Airport Authority were previously awarded a RISE Local Development grant to assist in roadway improvements to relocate the main Des Moines International Airport commercial terminal entrance onto Cowles Drive including turn lanes on Fleur Drive located on the southwest side of town. An amendment to the scope and grant award was requested to provide additional roadway improvements for the future terminal main entrance.

This amendment is necessary to provide improved access to the expanded Des Moines International Airport terminal for airport purposes. This project is anticipated to be completed by December 2022.

The evaluation and rating for the project will be discussed.

Craig Markley, Transportation Development Division, Systems Planning Bureau; The City of Des Moines and Des Moines Airport Authority were previously awarded a RISE Local Development Grant to assist in roadway improvements to relocate the main Des Moines International Airport commercial terminal entrance from Cowles Drive, including turn lanes on Fluer Drive located on the Southwest side of town, an amendment to the scope and grant award.

Stuart Anderson, Transportation Development Division Director; FY2022-2026 Iowa Transportation Improvement Program draft was released for comments last month. This program documents the allocation of \$3.6 billion of state and federal funding for highway right-of-way and construction projects on the state highway system. This program also documents actions and approvals over the past 12 months for multimodal and modal investment programs in Iowa, we did not receive any comments on the draft program.

It is also recommended the Commission approve the use of condemnation if necessary, to acquire property for the projects in the Highway section, and authorized the temporary transfer of funds from the RISE fund to the Primary Road Fund, if necessary.

Re: Request for Authorization to Borrow Funds from the RISE Fund

Dear Commissioners,

As we have for the last three years, we are requesting your authorization to temporarily transfer funds from the RISE fund to the Primary Road Fund (PRF) during state fiscal year 2022. This request is made pursuant to section 315.3(3)(b) of the Iowa Code, which states:

If the state transportation commission receives and files a letter from the director of transportation certifying that the cash flow funding of the department may be inadequate to meet anticipated road construction costs, the commission may authorize the temporary transfer of funds from the RISE fund to the primary road fund. Funds transferred under this paragraph shall be repaid to the RISE fund within six months of transfer.

By this letter, I am certifying the cash flow funding of the department may be inadequate to meet anticipated road construction costs during fiscal year 2022. As we have discussed in the past, it is not a certainty that we will need to borrow RISE funds to meet cash flow needs in the highway program, but there is enough uncertainty to PRF revenue and expenditures in fiscal year 2022 to suggest it is possible borrowing RISE funds may be necessary. Therefore, we believe it's prudent to request your authorization to do so. As with the past years, the uncertainty of PRF expenditures is due to several very large construction projects underway and the potential for increased drawdown of funds by local jurisdictions during this coming construction season.

As we are doing this year, we will continue to provide regular updates throughout the year on the status of PRF revenue and expenditures and will of course advise you if it proves necessary to borrow RISE funds. If we do borrow RISE funds, we do not expect that would impact your ability to continue to award RISE funding to all eligible projects. In addition, as required by Iowa Code, any funds borrowed and transferred will be repaid to the RISE fund within six months of transfer.

Our request for your authorization will be part of our recommendation for Commission approval of the 2022-2026 Iowa Transportation Improvement Program, and your authorization would be memorialized in the order approving the program. A copy of the proposed order is included with this letter. The authorization to borrow will apply through the end of fiscal year 2022 which is June 30, 2022.
