- General comments
 - 20 responses to the summit survey
 - Room was too cold
 - Good to see representatives from the MCOs
 - Good variety of topics
- All respondents recommended the summit
- Improvements
 - Extension cords, tables were too far away from outlets
 - Expand invitations to businesses/employers that often partners with their city's transit system so that they may have opportunities to brag and steal
- Future topics
 - Transportation solutions for kids
 - Connecting different transit agencies together
 - Funding opportunities
 - Passenger rail (existing or future initiatives)
 - Highlight a successful business (non hospital or state ran business) partnership (with the local transit system)
 - Panel of funding programs discussing how they are able to fund for public transits
 - What is working across the state (and what could potentially be duplicated)
 - Best practices to increase community participation
 - Uber health or other options that can work in collaboration with the transit providers across the state
- Biggest challenge you face with regard to passenger transportation
 - Finding drivers servicing rural areas
 - Having transportation available
 - Hiring, obtaining funding
 - Availability of qualified drivers, supply of well running equipment at an affordable cost
 - o Off hours and route for individuals with disabilities living in rural areas
 - Bus replacements
 - Helping the public to get to health appointments
