IV. ITCC Mission and Purpose – Emma Simmons

- **a. Mission:** to discuss and review transportation coordination issues and address institutional and/or regulatory barriers to coordination to provide the most transportations with the effective use of public investment.
- **b. Purpose:** To improve access to the community through transportation, to enhance costeffectiveness of coordinated transportation, and to strengthen interagency partnerships and collaboration with state, local, and industry groups.

c. Goals: Phase I- Educate council members

- i. Identify funding programs (private as well as public) that are or can be used to fund passenger transportation services.
- ii. Identify best practices in coordination.
- iii. Continue to identify root causes for lack of coordination.
 - 1. lack of awareness of current services
 - 2. perception that service can be provided less expensively
 - 3. perception that current service cannot meet the needs
 - 4. artificial service boundaries
 - 5. limited service
 - 6. consumer choice/preferences
 - 7. lack of awareness of potential partners
- iv. Look for opportunities for collaboration



d. Goals: Phase II- Educate public and raise level of awareness.

- i. Develop and education program in collaboration with transportation consumers.
- ii. Present the disability education program in each of Iowa's metropolitan areas.
- iii. Present a customized version to rural audiences in each of the state's transit regions.
- iv. Facilitate meetings between designated public transit systems and local human service and public health agencies to promote local coordination efforts.
- v. Inform public transit systems, other providers and funding agencies of various transit coordination practices found in Iowa or elsewhere.
- vi. Work to remove any state of federal regulatory barriers to coordination of publicly funded transportation services.

- **a.** The Code of Iowa, Section 324A.4, subsection 2, Code 2024, states the Iowa Department of Transportation (DOT) "shall biennially prepare a report to be submitted to the general assembly and the governor prior to December 15 of even-numbered years. The report shall recommend methods to increase transportation coordination and improve the efficiency of federal, state, and local government programs used to finance public transit services and may address other topics as appropriate."

 - 4. Currently, this is only available were Lyft services are operational

 - **1.** Looking into which providers are necessarily meeting members needs
 - **2.** Could Lyft relieve some of the gaps?

 - 2. Work on setting up some roundtable discussions

i. Vienna Hoang

- i. For IVRS, they just completed an Employment First training for all providers on the Western side of the state (expected 40 participants but had about 90!);
 - **1.** They will be doing another one on 12/10/24 for the Eastern side of the state at the Coralville Public Library.
 - **2.** This training is on how to use resources to support individual w/ disabilities into competitive integrated employment (CIE).
- ii. They also still have the Iowa Blueprint for Change grant which is a grant that allows the IBC to work with anyone and everyone who would like to do something to move individuals w/ disabilities in subminimum wage, contemplating it, or are in some type of day habilitation program into CIE.
