#### FTA RELAUNCHES ENVIRONMENTAL AND SUSTAINABILITY MANAGEMENT SYSTEMS PORTAL

At FTA's Earth Day event on April 22, 2024, FTA Acting Administrator Veronica Vanterpool announced the relaunch of FTA's <u>Environmental and Sustainability</u> <u>Management System (ESMS) program</u>. The training and technical assistance program will help up to five transit agencies develop and implement an ESMS at their facilities. An ESMS is a set of management processes and procedures that allows an organization to analyze, control and reduce the environmental impact of its activities, products and services, and operate with a greater efficiency and control. The <u>program</u> includes an on-site baseline environmental review, three virtual workshops, a virtual gap audit and an on-site final audit.

Transit agencies interested in applying for the program should submit a signed letter of application by May 22, 2024, as outlined in the application instructions. More information about the program, reports of past rounds, and a suite of ESMS resources can be found on FTA's <u>ESMS website</u>.

### KRISTIN'S KEYWORDS

Hello, September! Fall is my favorite season, so I am happy to see this month on the calendar. I love autumn for its cooler temperatures, changing colors, football (Go Cyclones! And 49ers! And all Midwest NFL teams!), and anticipation of my favorite holidays of the year.

This year, September was a welcome sight on our work calendars because it meant we got through our latest State Management Review (SMR)! The FTA and its contracted review teams conduct SMRs of state DOTs every three years. The Public Transit Team began answering questions for the FTA-contracted reviewers back in January and February, had an inperson training with the reviewers in March, and participated in the on-site SMR August 27-29. As expected, we had a few deficiencies to correct four to be exact - but most of them will be easy and quick to fix. I would like to thank those transit agencies chosen for visits by the reviewers as part of this process for your availability, preparation, and cooperation: Dylan Schulte/Mason Citv Transit, Mark Newbera/ PeopleRides, Dennis Hart/Clinton MTA, and Brock Grenis/CorridorRides. We approach the SMRs as a learning experience. Take the input, improve, and move forward. Let's move forward!

I also like Fall on our work schedule. It is exciting to review the STA Special Project applications to see what new, innovative projects and partnerships you and your fellow public transit agencies are proposing. Reviewing the Intercity Bus applications can also be gratifying as we know our recommendations for funding can mean many trips connecting to points around the country for passengers who may not have the means or ability to travel any other way. Keep in mind that transit agencies are eligible to apply for Intercity Bus funding to provide services connecting to the national transportation network. If interested, both applications are available through BlackCat and are due October 1.

Fall, too, means the start of year-end financial and statistical reviews. Sometimes these reviews can look like that yard full of leaves to be raked. No one wants to do the raking, but the yard looks so good when it's done. As we start our FY24 yearend reviews this Fall, I encourage all of you - DOT staff and transit managers alike - to remember how good it will feel when they're done! I anticipate the FY24 yearend reviews to be finished earlier than FY23; Laura and Matt now both have a year-plus transit experience and I'll be in a supporting role to help. the sooner they are done, the sooner next year's FTA formula STA and dollar projections can be calculated next Spring. The information we gather through these reviews help us do our annual reporting to the National Transit Database.

In July, we learned Iowa was not selected for either competitive FTA 5339 bus and bus facilities or Iow-no emission grant. These are highly competitive, over-subscribed programs and we have been very for fortunate to have been funded for multiple years in a row. We have been told our regular bus and bus facilities grant was highly rated, just not chosen for the award. For the Iow-no emission grant, we participated in a de-brief with the FTA contact for the program to determine ways we could improve our position in future applications. We received comments on the demonstration of benefits and local financial commitment sections as areas for improvement. Emma will work with the participating transit agencies next year on those, and all, areas so we are more competitive for funding selection.

The Iowa DOT Public Transit Team will present at the IPTA Mid-Year Meeting on October 7 in Ankeny. If there are any topics you'd like us to cover specifically during that presentation, please let me know. In the meantime, enjoy the season of Fall. Thank you for all you do for public transit in Iowa.

### 2024 RURAL TRANSIT FACT BOOK PUBLISHED

SURCOM has published an updated edition of the Rural Transit Fact Book. This publication is intended to serve as a national resource for statistics and information on rural transit in the United States. The Fact Book includes rural demographic and travel behavior data as well as financial, operating, and fleet statistics and performance measures for agencies receiving Section 5311 funding. In addition to national level data, statistics are presented by state, FTA region, tribe, and mode, as well as other agency characteristics.

The Rural Transit Fact Book presents data from the National Transit Database (NTD) and rural demographic and travel data from the American Community Survey. ### CONGRATULATIONS TO CAMBUS ON THEIR LOW-NO AWARD!
