#### **MISSION STATEMENT**

#### The Iowa Mississippi River Parkway Commission (IAMRPC) was organized to:

- Preserve, promote, and enhance the scenic, historic, natural, archaeological, cultural, and recreation resources of the National Scenic Byway (NSB)/lowa Great River Road (GRR) and the Iowa Mississippi River Valley.
- Foster economic growth of the Mississippi River corridor.
- Develop the National Scenic Byway/Great River Road.

# **ALL AMERICAN ROAD**

Established in 1991, the National Scenic Byways Program recognizes roadways with notable scenic, historic, cultural, natural, recreational, and archaeological qualities. Scenic America, a national environmental nonprofit that preserves and enhances the visual character and scenic beauty of America, led the charge to revitalize and restore funding for the program.

This past year the Great River Road was nominated and received the designation as an All-American Road (AAR). With the Federal Highway Administration (FHWA)'s announcement of 15 All-American Roads, this marks the first additions to the program since 2009. This is a national designation and joins such roads as the Appalachian Trail and the California Scenic Highway. In addition to being a major task and accomplishment to achieve this status, this designation also gives the Road an opportunity for additional funding.

# **VISION**

The Iowa Great River Road will sustain rewarding lifelong experiences for Iowans and visitors from around the world through the support of a cooperative network of partners and stakeholder, each of which invest in and benefit from the conservation, development, promotion, interpretation, and management of the diverse intrinsic resources of the Iowa Mississippi River Valley.

(Adopted December 15, 2014).

#### **GOALS AND OBJECTIVES**

- Assist in coordinating the increase of investment and awareness of the National Scenic Byway/lowa Great River Road, and All American Road and its amenities with roadside parks, scenic overlooks, educational experiences and opportunities and historic information.
- Continue the identification, documentation, and protection of the intrinsic resources of the Great River Road.
- Expand the local citizen awareness of the resources and importance of the Great River Road in Iowa and the adjoining states.
- Provide new travel experiences through effective interpretation and promotion of the Great River Road.
- Increase information services to residents and organizations along the Great River Road.
- Identify economic development opportunities based on the sensitive use of the Road's intrinsic resources.
- Sustain existing alliances with other organizations that are interested in the future of the Great River Road and develop new partnerships where needed.
- Identify volunteer opportunities for individuals and organizations along the Great River Road.
- Assist in coordinating the increase of investment and awareness of the Great River Road and its resources with development of a variety of amenities and delivery of programs for public awareness, interpretation, and promotion.
- Increase the awareness for Great River Road stakeholders of availability of public and private funding for resource conservation, transportation enhancement, interpretation, and promotion.
- Develop communication opportunities to tell the stories of the National Scenic Byway/Great River Road, and All American Road.
- Advocate for the Great River Road Interpretative Centers.
- Advocate for the Great River Road research, planning, and development studies.
   Advocate for transportation related projects in the Great River Road Corridor that incorporate the principles of context sensitive design.
- Advocate for the use of sustainable design principles such as L.E.E.D. (Leadership in Energy and Environmental Design), native plant community restoration, multi-functional streets, etc.
- Conserve, develop, promote, and interpret, and manage the Iowa Great River Road. (Adopted December 15, 2014).

A major factor in achieving these goals and objectives is partnering with area and national groups and associations that have similar goals and interests. By networking with other organizations, we can best utilize all our assets, including financial, contacts, and personnel.

# **IOWA MRPC STRUCTURE**

The Iowa Commission consists of ten commissioners appointed by the Governor of Iowa representing the ten counties that border the Mississippi River. The commission by Iowa statue is gender and politically balanced. In addition, there are five technical members representing: Iowa Department of Transportation, Department of Economic Development, Iowa Department of Natural Resources, Iowa Office of Tourism, and U.S. Army Corps of Engineers.

# **Iowa Commissioners' General Activities**

The Iowa Chair and or his proxy participated in all National MRPC Board meetings and Executive Board meetings, as well as the Annual Meeting conducted via Zoom, September 2021. The 2021 semi-annual meeting was cancelled because of Covid-19. The majority of Iowa Commissioners also participated in the National MRPC committee meetings.

Commissioners visit the eighteen Interpretive Centers and focus particularly on their respective Centers within their individual counties and provide materials for distribution and review the activities of each center and address any concerns.

Individually commissioners have been telling the Great River Road story in their individual counties. In addition, many commissioners meet with their elected officials and local citizens in addition to a formal annual meeting

The Iowa MRPC met on five separate occasions in the past year. October 18, 2021 at the Putnam Museum and Science Center, Davenport, Iowa; December 6, 2021 conference call; January 10, 2022 conference call; February 19, 2022, conference call; April 29, 2022 Mississippi River Eco Tourism Center, Camanche; July 18, 2022, Elkader. Minutes of these meetings are included as a part of this report.

The Commissioners voted to spend more money on advertising to continue the radio and added billboards. Radio ads generally ran the month of June. The Commission extended that to February – March and continued ads mid-May through June. The advertising area was extended to northwest lowa, and added streaming. Billboards were added to the marketing budget, and a full-page ad was purchased in the fall campground issue of Travel lowa. This now focused on activities along the Road to all four seasons. In addition, the commission activated the dormant Facebook page and began getting hits.

A project was brought to the Commission to build an interpretive route focusing on the northern journey through lowa of Zebulon Pike using his own words. This would include brochures, streaming, and looping videos for each Interpretive Center. The Commission reviewed the initial plan and began working to secure funding which will become a multi-year project.

# **IOWA MRPC BUDGET**

The Covid-19 virus required the cancellation of the annual semi-annual in-person meeting, and two meetings were held over zoom. The 2022 fall meeting will be in-person in Memphis.

# **ADVOCATING ACTIVITIES**

# Marketing

The Commission is continuing to focus on raising awareness of the Road and to catch the attention in different ways than have been used before. It is adding the All American Road designation to its signage and advertising. Also adding the "winter" radio ads to its agenda, it added focus not only to spring, summer, and fall tourism, but the opportunity to see the river in winter and enjoy the American Eagles as they fish. It also funded a full-page ad in the fall camping edition of Travel lowa.


By the time the Commission held its March meeting the semi-annual meeting was cancelled because of Covid-19, and the possibility of future meetings was in question. As a result of the impact this would have on travel along the Mississippi, the Commission expanded its previously discussed focus on marketing. One of the changes which eventually had the biggest impact was the increase of radio ads, which are regionally crafted, from six (6) weeks to eight (8) weeks, and did winter ads from February and March, and added billboards. There were billboards on the east coast, center, and west coast of lowa. This had a positive result because with tourists now taking trips closer to home. The ads, which added streaming, have resulted in a large increase in on-line traffic, which has shown longer times spent than is usual for on-line visitors. The national office is again sponsoring on-road activities.

Passports are still available at the Interpretive Centers for visitors to take and focus on visiting centers of which they may not have been aware. The Commission distributed 2,000 of them in the spring of 2021 and is having another 2,000 printed. They have been shown to very popular with visitors.

# **Great River Road Interpretive Centers**



# THE ROAD

#### BURLINGTON

In Burlington's bluff top Crapo Park, the bridge spanning Cascade Ravine has been closed to motor and pedestrian traffic. The bridge built in 1896 connects downtown Burlington with Crapo Park via South Main Street and is the recognized route for the Iowa Great River Road. It is the oldest Bridge in Iowa and is listed on the National Register of Historic Places. It is now showing its age. Burlington stopped letting vehicles travel across Cascade Bridge in 2008, and it was closed last year totally for walkers and well as bikes. A preliminary study has been completed and the City of Burlington has this on their list of bridges to be replaced. The City of Burlington has it on its extended development plan, and citizens continue to apply for grants and other funding to replace it. Lisa Walsh, Des Moines County Commissioner, has played an active part in support of those activities, and the Commission is lending support to the saving of the structure, or a viable replacement.

# CANADIAN PACIFIC, SANTA FE RAILROAD MERGER

The Canadian Pacific and Santa Fe railroads have applied to the Surface Transportation Board to add another fourteen (14) trains to its route transporting crude oil from Canada to Mexico. Ann Geiger, Scott County Commissioner, has been actively working in opposition to this merger, because the proposed route would cross the Mississippi River at Sabula and continue along the Great River Road to just south of Muscatine. In places, these trains would run right next to the road and within approximately 25 feet of the Mississippi River. Any derailment could result in damage to the road and anyone living next to it, or to the river.

#### **Bellevue**

This past year the Commission is still trying to get the information, with no success, regarding the development of the Great River Road copies to put in a more secure, temperature-controlled environment. In this house is the paperwork for the development of the Great River Road as a national byway. The legal documents are signed by the governors of the states at the time it was approved by Congress in 1938. Also included are maps and letters sent back and forth to Washington D.C. Within a year the precursor of what is now the Mississippi River Parkway Commission was formed, and the documents for that are also included.

# 2021-2022 Iowa MRPC Meeting Minutes

Minutes of the Iowa Mississippi River Parkway Commission are always public record. Public notices and meeting minutes are also posted here:

Graber called the meeting to order.

Present: Lisa Walsh, Paul Carroll, Paula Mayer, Jane Regan, and Ann Geiger

Absent: Jerod McGovern

Others: Emily Whaley, DOT; Craig Markley, DOT; Leslie Klipsch, Putnam Museum

Mayer moved the minutes of the July 19, 2021. Regan seconded and the motion carried.

Meyer moved the treasurer's report Geiger seconded and the motion carried.

Graber said the National Office's fiscal year is on the Calendar year. The Commission paid \$7,500, half the national dues. He asked if the Commission wanted to pay the other \$7,500. There were no expenditures for the fall meeting since it was a zoom meeting, so the money is in the budget. Geiger moved to not pay the additional \$7,500 to the National Office by December 1st for it annual dues. Mayer seconded the motion and it carried.

Motion to authorize 5-year \$95.96 payment for GoDaddy to host Iowa website. Mayer said she would contact GoDaddy and asked for reimbursement. Moved by Carroll to approve the expenditure and reimbursement, Regan seconded the motion and it carried.

Discussion was held regarding the Iowa Byway Foundation. Walsh moved to approve a \$250 donation for the year. Mayer seconded the motion and it carried.

Geiger said she had been contacted by one of the radio stations to focus on winter activities for the Road, and any ICenter winter activities up to \$4,500. The Commission wants start the ads in November and run until February. Spreading ads out and running part of the week will stretch the budget. Motion to approve the running of the ads by Carroll, seconded by Regan and the motion carried. Markley asked about taking bids since the amount of the expenditure was over \$1,500. A discussion was held referencing prior ads and the amount of free ads each station would offer. There are basically two conglomerates which control the stations in Iowa. Geiger asked why this would be any different than any of the other ads which the Commission has run for years. She asked if this could be done and approved by November and was assured it could be done. Mayer and Regan said they would get quotes.

Mayer asked about spending a small amount of money for facebook ads to see if it would be beneficial. Mayer moved to start with \$200 to run until the end of the year. Regan seconded the motion and the motion carried.

Geiger said there have been requests for road maps and the passport. Walsh said the National Office did not have enough money for the maps. Geiger said Janett requested some of the maps for Lansing from the National Office and they sent him one with the opportunity for a donation.

The passports are going to be reprinted. There was discussion about removing the stamp portion of the document, and some of the commissioners said some of the Centers liked having them. It provides some interest in pursuing other visits.

**Chairman's report.** Graber asked Walsh to give the report since he was not able to attend. Walsh said the National Office was very happy about the zoom attendance for the fall meeting. Other than running the video of the Road, there was no formal program. All the committees met for an hour and then gave reports to everyone. There was a discussion regarding sending a letter of support to Mississippi River Towns and Initiatives. Some of the board members were not in favor, and Walsh pointed out the amount of corporate financial support it had. A letter was finally agreed upon.

#### **Comments from Interpretive Centers Ex-Official Members and others**

Markley reviewed the Guidance document for the Commission. There was a lengthy discussion regarding approval of Pilch and Barnett's job.

# **Update on Activities**

Cascade Bridge. Walsh said there is still no movement, but the new city manager seems to be more open to a solution than previous administrators.

Young Museum. Geiger said access has been impossible. The manager will not grant access and the material is sitting on the floor in unclosed archive boxes. She said the National Office sent a letter and it did not go well. Graber said former member, Attorney Jay Schweitzer, was pursuing the situation and thought the final resolution may have to go to the courts. Both Geiger and Regan suggested finding out when the board met and attend.

Fish Hatchery. Carroll applied through Toyota's Grant National Scenic Byway Foundation. The Hatchery received a \$2K grant for materials and site improvement. United Way and

River Action have used the facility for meetings. The Hatchery is doing a mussel display inside the building. It also got large family donation and Carroll would like to discuss the best use of it with them further. The trails have been improved. A friends group has been formed and Sandy Stephens, is the driver. Linn Pruitt, a member, is on the historic preservation commission.

Zebulon Pike. Carroll said he will get an update soon. Geiger suggested discussing it further in the Non-profit meeting.

Pine Creek Grist Mill. The Mill has closed for the season and has a new director – Ben Marcus.

Sawmill Museum. The Museum is celebrating its 10th anniversary with activities all year long.

Mines of Spain – It is awaiting a 28 E Agreement which would put management of the EB Lyons Center in the hands of Dubuque County Conservation. Hopefully there will be agreement by all parties and by November 10th it can go to the State Natural Resource Commission. The agreement will be between the City of Dubuque, Iowa DNR, Dubuque County Conservation, and the Friends of the Mines of Spain. The Friends of Mines of Spain have been working on this for 7 years.

Hurstville – It has been finishing up a new trail. At the Center the paving is complete. They are working on a Bridge next to connect the trail to the road. Eventually the trail will connect with the section coming north from Maquoketa.

Putnam Museum. Klipsch said the museum is open again with a mask requirement. It is restoring staff and visitors and school groups are coming back. Putnam is hosting a new exhibit opening in November called Winter Wheels - an antique motorcycle exhibit. It got an IMLA (Institute of Museum and Library Services) grant for a regional history update It is the only institution in Iowa to get one and is a multi-year project..

#### **Iowa Byways**

Mayer has emailed all ICenters requesting updates to include in the next Byways newsletter, and she emailed Jared Nielsen for assistance in being host to the November Byways meeting.

Next meeting will be January 10th. Geiger will check on the Camanche's Eco Center

#### Call to order and roll call

The meeting was called to order by the Chair at 10:45

Strong said he was new with the Dispatch and has been joining meetings when possible. Graber said he would be glad to meeting with him and telling him more about the organization when he is in Des Moines.

#### Discussion and approval of winter radio ads

Geiger said she spoke with Pat O'Brien at WENN and they said they would do the promos and put them on MP3's for \$3,000.

Regan said she would reach out to IHeart, and other radio companies to cover the state. She would ask them to focus on NW and central Iowa She asked for a dollar amount to spend. The Commission would like to spend \$7,500 on radio ads.

A discussion will take place at January meeting on the google ads which Travel Iowa has and a review of available budget.

Janett said Lansing got a lot of central and northwest Iowa this past fall visiting. He asked if the ads needed to be tweeked. Regan said yes. When asking for ideas for the winter ad, Walsh said there is eagle-watching, the road is open, and the river is beautiful. Janett suggested in the ad it be mentioned to check with the local centers for programs, hours, and activities during the winter. Graber wanted to be sure everyone knows there are ICenters open all winter for visitors. Regan asked that each of the ICenters have their information up to date with Travel Iowa and she would discuss with Mayer.

Regan suggest IHeart come up with a time frame for running the ads, and get the Saturday morning ads.

The Tri-State area and western Iowa are the focus. McGovern asked why we were advertising in Western Iowa. Geiger said at a meeting several years ago she became aware the people on the western portion of the state were uninformed about the Road and tourism from the western part of the state has improved.

Co-ops in digital campaign have two spots left at \$1,500. Kenne said they were made available last year for \$2,500 instead of \$3,000, and she would use that price again.

On motion by Mayer to take the 2 slots for digital coop ad for \$2,500 with a second by Webster and the motion carried.

Kenne said the Commission has sponsored listing \$450 Apr - June on traveliowa.com for lodging, with sponsors listed at the top. Last year it did \$600 - Mar - June. From Mar – June had almost 102,948 impressions. Click rate of 1.59%. It is a very high percentage. Very little difference in prices from last year for this year. Availability will change.

Last year had a reach of 4,676 people looking at the ads on facebook. Mayer suggested adding northern IL to the list of ad hits. Mayer updated the success of the facebook page. She has 1,500 people who follow the page, and she checks the "likes". She has been sharing over the Travel Iowa Passport program. Geiger said if we can cover Galena, we will get through to the Chicago market.

Mines of Spain. McGovern said the facility is open for the first time in a while. The Mississippi River Museum is seeing huge numbers of visitors, and will give all the school children an outdoor experience with new displays and projects. It also added STEM to its program. The museum just updated its comp plan. County is using rescue money for tourism and to the Field of Dreams to increase and do improvements.

Rail Merger. Geiger gave an update on the potential merger of the Canadian Pacific and Santa Fe railroads which will add 14 more trains to its schedule moving crude oil from Canada to Mexico along parts of Iowa's Great River Road and next to the Mississippi River. She said the trains would cross from Illinois to Iowa at Sabula and run down Iowa's east coast to the south side of Muscatine where it would turn west. Portions of the tracks run less than 50 feet from the river, and trains go off the tracks regularly. An example is the coal car that dumped into the river near Lansing a few weeks ago. Janet said there were 5 cars that dumped into the river. The Iowa Environmental Committee said if the oil dumps into the river, it will not pool but go into the river bottom and stay. Geiger spoke with the Surface Transportation Board (STB) and the Environmental Committee and both said they would like to her from citizens. Geiger will send information to the Commissioners to encourage people to respond to the STB which has the final say.
