

# Motor Vehicle Division Information Memo # 19-09 Operating While Intoxicated Administrative Rule Updates

## **SUBJECT**

This informational memo explains an update to administrative rule chapter 761—620, Operating While Intoxicated (OWI). In 2018, Iowa Code chapter 321J was amended to alter the requirements related to a temporary restricted license (TRL) and installation of an ignition interlock device (IID).

## **SUMMARY**

The rule amendments conform to the following changes from the 2018 legislation:

- Extends the requirement to install an IID as a condition of a TRL to a subset of OWI offenders who had not previously been required to install an IID as a condition of a TRL, for example, applicants whose test results demonstrated a blood-alcohol content of .08 to .10.
- Removes the periods of ineligibility (i.e., hard suspensions) for most OWI offenses so that an applicant no longer must wait a specified period of time after committing an OWI offense before the applicant may apply for a TRL.
- Removes the driving location restrictions for an applicant obtaining a TRL authorized under lowa Code chapter 321J.

The rule amendments also reflect a new TRL application form number and conforms the rules to requirements in Iowa Code chapter 321J requiring an IID to be installed in all vehicles owned or operated by the applicant as a condition of the TRL.

The administrative rule amendments are effective April 17, 2019.
