What is the intended benefit of the rule?

This chapter lays out uniform requirements, responsibilities, and procedures for requesting the installation of various types of signs on the interstate and primary highway systems within lowa. These signs benefit road users by providing directions to nearby destinations or by providing supplementary information about the highway.

Is the benefit being achieved? Please provide evidence.

Yes. The rules are followed by Department personnel when processing requests for signing. Applications complying with the rules result in approval and installation of the appropriate signs.

What are the costs incurred by the public to comply with the rule?

Choosing to request a sign is completely voluntary.

Costs incurred by the requester depend on the type of sign:

- Organizations requesting signage for special events must furnish and install their own signs.
- Civic, religious, and nonprofit charitable organizations requesting signage for organized off-highway camps pay the Department to fabricate and install the signs.
- Citizens or groups requesting signage for a scenic trail, historic trail, memorial bridge, or memorial highway furnish their own signs and pay the Department to install the signs.

The cost for signs fabricated by the Department is based on the sign material and the size of the sign. Small aluminum signs cost \$7.99 per square foot and larger plywood signs cost \$9.50 per square foot.

Typical sign installation costs are \$200 and are based on historical averages for labor, equipment, and materials.

What are the costs to the agency or any other agency to implement/enforce the rule?

Department personnel processing the requests do so as part of their assigned duties.

Costs to the Department depend on the type of sign:

• Destination signs at secondary road intersections are fabricated and installed by the Department free of charge.

- Business route signs are installed by the Department free of charge.
- School signs are fabricated and installed by the Department free of charge.
- Camping service signs on interstates are fabricated and installed by the Department free of charge.
- Sanitary landfill signs are fabricated and installed by the Department free of charge.
- County conservation park signs are installed by the Department free of charge.
- No parking signs on rural primary highways are fabricated and installed by the Department free of charge.

Cities bear the cost of furnishing business route signs.

Counties bear the cost of furnishing county conservation park signs.

Do the costs justify the benefits achieved? Please explain.

Yes, the costs to fabricate and install these signs is minor compared to the increased awareness and navigation guidance they provide.

Are there less restrictive alternatives to accomplish the benefit?

Yes. Minimum requirements for certain types of signs could be softened. Examples of current minimum requirements include:

- Colleges and universities must have a minimum enrollment of 500 full-time students in order to qualify for a school sign.
- Campgrounds must be within 5 miles of the nearest off-ramp intersection in order to qualify for a camping service sign on the interstate.
- Special events must have an expected attendance of over 10,000 people per day in order to qualify for signing.

The minimum requirements provide uniformity, and they have been in place for many years, so it is recommended to keep the requirements in place.

The Department could choose to no longer charge sign fabrication and installation costs. That, however, would likely lead to a significant increase in:

- Requests for the Department to process,
- Costs to the Department, and
- The number of signs on the highways.
