**City of Dubuque/Dubuque Metropolitan Area Transportation Study (DMATS)**

City of Dubuque Mayor Roy Buol will welcome the Commission to Dubuque and thank them for the SW Arterial project. He will be joined by Dubuque Assistant City Engineer, Bob Schiesl who will present on the Dubuque to Rockford passenger rail feasibility study, Gavillon Port improvements, Chavenelle bicycle/pedestrian trail, and several roadway projects.

**Dubuque County**

Ann McDonough, Dubuque County Board of Supervisors Chair, will thank the Commission for the investments in Dubuque County. She will be joined by Anthony Bardgett, Dubuque County Engineer, who will present information on the John Deere Road Corridor Project.

**Region 8 Regional Transit Authority**

Kelly Deutmeyer, Executive Director for Region 8 Transit will discuss the impacts of COVID -19 on the transit agency along with the issues they faced, measures they took and how it has prepared them for future emergencies.
