## Appropriations

- ★HF 752 **Makes transportation and infrastructure-related appropriations to the DOT from the Road Use Tax Fund and the Primary Road Fund. Appropriates \$316.5 million from these funds and allocates 3,374 full-time equivalent (FTE) positions to the DOT. Includes appropriations for development of an International Registration Plan and International Fuel Tax Administration system, for construction of a new Clarinda garage, and for elevator upgrades at the Ames complex. (Sections 50 and 51 of SF 601 increase the amount appropriated to the DOT for utility payments to the Department of Administrative Services. The Governor issued an item veto of Section 3, language which would have required the DOT to assess the department's use of telecommuting and develop a policy and plans to expand the number of telecommuting employees.)**
- HF 787 Appropriates funds from federal grants to various state agencies. Section 54 appropriates federal and other nonstate grants, receipts, and funds for the fiscal year beginning July 1, 2007, to the DOT for the purposes set forth in the grants, receipts, or funds.
- HF 874 Makes appropriations to various state agencies, positions, and funds, including the Department of Administrative Services (DAS), the Department of Management, the Governor's Office, and for state-federal relations. Appropriates \$2 million from the General Fund to DAS to distribute to other government entities to pay for services associated with the Integrated Information for Iowa (I-3) system. Requires the first \$1 million of fees collected for furnishing certified abstracts of motor vehicle operating records be transferred to the IowAccess Revolving Loan Fund to maintain and expand electronic access to government records. Allows DAS to assess a monthly \$2 per contract charge on all health insurance plans administered by DAS. Appropriates moneys from Use Tax receipts, the Road Use Tax Fund, and the Motor Fuel Tax Fund to various state agencies to support administrative services provided to the DOT. Includes various effective dates. (HF 911, Section 8, strikes the \$2 million General Fund appropriation to DAS for the I-3 system costs. The Governor item vetoed Section 19, unnumbered paragraph 2, and Section 25.)
- HF 890 Relates to assistance for small businesses. Allows a state agency to purchase directly from a vendor when the purchase will not exceed \$10,000. Requires all state agencies to establish

annual procurement goals for purchasing from certified targeted small businesses and report the total dollar amount of such purchases to the Department of Economic Development within 15 business days following the end of each calendar quarter. Requires the Auditor of State to conduct an annual review of whether state agencies are meeting their annual small business procurement goals. Appropriates moneys for various purposes in support of targeted small businesses. Takes effect upon enactment, May 22, 2007.

- ★HF 911      Makes appropriations from the Rebuild Iowa Infrastructure Fund (RIIF), the Vertical Infrastructure Fund, the Endowment for Iowa's Health Restricted Capitals Fund, and the Technology Reinvestment Fund to various state agencies, including the DOT. Section 1, subsection 2, appropriates \$2 million to Department of Administrative Services from the RIIF for distribution to other governmental entities to pay costs associated with the Integrated Information for Iowa (I-3) system. Section 1, subsection 15, makes FY 2008 appropriations to the DOT from the RIIF, including \$2 million for acquiring, constructing, and improving recreational trails within the state, with \$185,000 allocated for the Jewell-Ellsworth trail; \$200,000 for the Fairfield loop trail; and \$30,000 for the Crawford County trail; \$1.5 million for infrastructure improvements at commercial air service airports; and \$750,000 for infrastructure improvements at general aviation airports. Section 1, subsection 15, also appropriates \$2 million for deposit in the Railroad Revolving Loan and Grant Fund, with the intent that the appropriation be used to generate at least \$10 million in vertical infrastructure capital investments and allowing up to \$100,000 to acquire and install close-clearance warning devices along railroad tracks consistent with SF 472. Section 2 provides that these funds remain available through FY 2011 or until the projects are completed, whichever is earlier. Section 16 appropriates \$20,000 to the DOT from the State Aviation Fund to assist an aviation authority that has lost a federal essential air service carrier. Sections 18 and 20 amend the 2003 and 2005 Iowa Acts to allow certain moneys appropriated to the DOT from the Restricted Capital Funds Account of the Tobacco Settlement Trust Fund to remain available through FY 2008 or until the projects are completed, whichever is earlier. Sections 25 and 27 amend the reporting requirements when a state agency receives an appropriation from the Endowment for Iowa's Health Restricted Capitals Fund or the Rebuild Iowa Infrastructure Fund. Section 40 amends Code section 328.56, subsection 2, concerning the State

- Aviation Fund to appropriate the funds to the DOT for certain purposes, including marketing at commercial service airports. Includes various effective dates. *(Section 8 strikes HF 874, Section 1, subsection 1, paragraph c, which appropriates \$2 million to DAS from the General Fund for I-3 system costs. The Governor item vetoed Section 1, subsection 1, paragraph g; Section 1, subsection 4, paragraph c; Section 4; and Section 5.)*
- SF 562 Makes appropriations to the Department of Cultural Affairs, the Department of Economic Development, the Board of Regents institutions, the Department of Workforce Development, the Iowa Finance Authority, and the Public Employment Relations Board. Section 17, subsection 3, requires the Legislative Services Agency to conduct an annual review of salaries paid to employees of entities organized under Code chapter 28E and report its findings to the Joint Appropriations Subcommittee on Economic Development.
- SF 575 Makes appropriations to the Department of Justice, the Department of Corrections (DOC), the Department of Inspections and Appeals, the Iowa Law Enforcement Academy, the Board of Parole, the Department of Public Defense, the Department of Public Safety, and the Iowa State Civil Rights Commission. Section 7 allows the DOC to cooperate with the counties to use inmate labor to clean up roads and water sources around the state. Section 9 requires state agencies to obtain bids from Iowa State Industries for purchases of office furniture exceeding \$5,000 or in accordance with the agency's administrative rules. Section 14 states it is the intent of the General Assembly that members of the state patrol be assigned to patrol highways and roads in lieu of inspecting school buses for the school districts. *(The Governor item vetoed Section 20.)*
- SF 588 Makes appropriations to the Department of Education, the College Student Aid Commission, the Department for the Blind, and the Board of Regents. Includes various effective dates. *(The Governor item vetoed Sections 5 and 15.)*
- SF 601 Relates to the compensation and benefits for public officials and employees; makes, increases and reduces appropriations; provides for funding of property tax credits and reimbursements; provides for tax credits; provides for fees and penalties; and provides for related matters. Section 2 addresses

Section 1 allows the DOT to employ a registered associate real estate appraiser under the direct supervision of a certified real estate appraiser.
- SF 200 Relates to fencing and provides that the owner of land where livestock is kept is liable to erect or maintain a fence if the livestock strays from the land onto a public road.
- SF 339 Relates to county general obligation bonds by modifying the definition of essential county purpose to include capitol projects for the construction, reconstruction, improvement, repair, or equipping of bridges, roads, and culverts if the capital projects assist in economic development and create jobs and wealth.

This provision applies to applications filed within three years of the time an Iowa Great Place project has been identified.
