Urban-Rural Classification

- For the 2010 Census, to qualify as an urban area, the territory identified according to criteria must
 - encompass at least 2,500 people, at least 1,500 of which reside outside institutional group quarters.
 - The Census Bureau identified two types of urban areas:
 - Urbanized Areas (UAs) of 50,000 or more people;
 - Urban Clusters (UCs) of at least 2,500 and less than 50,000 people.
- For the 2020 Census, to qualify as an urban area, the territory identified according to criteria must
 - encompass at least 2,000 housing units or
 - have a population of at least 5,000.

2020 Urban Areas by Planning Agency

- · See handout.
- Most urban areas listed met the Census definition of urban area for both population and housing units.
 Exceptions were:
 - Cherokee, IA (RPA 4) Housing Unit
 - Manchester, IA (RPA 8) Housing Unit
 - Vinton, IA (RPA 10) Housing Unit
 - Polk City, IA (RPA 11/DMAMPO) Population
 - Shenandoah, IA (RPA 13) Housing Unit
 - Harlan, IA (RPA 18) Housing Unit



Quick Observations

- Iowa's total population increased by 144,014 (4.73%)
- lowa's MPOs (lowa side) population increased by 150,210 (11.84%)
- Iowa's non-urbanized population (non-MPO) population decreased by 6,196 (0.35%)
- RPAs 3, 9, 10, 11 saw their non-urbanized area population increase.
 - If you include MPOs in total RPA population, add RPA 4 and RPA 8 for increase
- Largest growth
 - MPO Des Moines MPO (92,416)
 - RPA (non-urbanized) RPA 11 (14,511)

Quick Observations

- RPA 2 lost the most people (-4,175)
- RPA 13 saw the largest population percentage loss (-5.82%)
- 14 RPAs saw their non-urbanized population decrease
 - RPA 1, 2, 6, 12, 13, 14, 15 saw a population decrease in every county



Quick Observations

- Total RPA Population (including UZAs)
 - RPA 7 went from 3rd largest population to 4th
 - RPA 9 went from 4th largest population to 3rd
- Total Non-urbanized Population
 - RPA 9 went from 15th largest population to 14th
 - RPA 18 went from 14th largest population to 15th
- Iowa City passed Waterloo, moving from 5th largest MPO to 4th largest.
- RPA 5, 11, 17, 18 saw instances where counties (total population) flipped ranking.
