HISTORY

- 2015-2018: Counties started developing LRSPs in conjunction with lowa Dot Office of Traffic and Safety; \sim 59 counties completed a plan; Kimley-Horn was the consultant who completed all 59 plans
- SS4A Notice of Funding released June 28th, 2022
- ICEA Leadership made the decision to apply for a statewide SS4A planning grant to provide all 99 counties with an SAP
- Announcement made at ICEA Mid-year meeting on July 14th, 2022 of intention to apply for the grant and to be prepared
 to take a resolution to participate to Board of Supervisors for approval
- Aug 17th, 2022 97 resolutions and required information from each county returned and ready for submittal
- 97 Counties included
 - Mahaska County Lead County
 - Polk County went with MPO application
 - Fayette County had a valid safety plan, went after and was awarded \$15+ million construction dollars
- SS4A Award Announced: 1/31/2023
- FHWA Grant Agreement signed: 7/27/2023
- Kimley-Horn selected as consultant, begin work date of: 10/17/2023
- 3 All 97 County's plans complete by final grant date of: 7/27/2025

STRATEGY

- 3 Project Teams running concurrently, divided by Districts
- Project Teams supported by overall project resource leads, overseeing all data analysis and evaluation
- 97 counties divided into Phase 1 and Phase 2 groups
 - Based on the results of a questionnaire
- Safety Workshops, one for each county
 - Discuss specific countermeasures and safety strategies that can be implemented based on the types of crashes occurring locally
- SAP Development
 - Phase 1 group completed by 03/2025
 - Phase 2 group completed by 07/2025
