Federal Recreational Trail Program

- Federal program created in 1991
- Available to federal, state, and local government agencies. Private individuals and organizations may apply with a government co-sponsor.
- Purpose is to develop and maintain recreational trails and trail related facilities for both motorized and nonmotorized trail users.
- Eligible projects include:
 - Maintenance and restoration of existing trails, development of trailside and trailhead facilities, purchase of trail construction and maintenance equipment, construction of new trails, and acquisition of land for trails.



Project Evaluation Criteria

- Degree to which motorized and non-motorized trail use are accommodated. (10 points)
- Greatest number of compatible multi-purpose uses. (10 points)
- Access and use for persons with disabilities, older citizens, economically challenged and other special populations or groups. (10 points)
- Provides development of trail linkages. (10 points)
- Opportunities for new partnerships between trail users and private interests. (10 points)
- Identified in or furthers a specific goal of a state, regional, or local plan. (10 points)
- Leverages greater public or private investments. (10 points)
- Citizen involvement in the project's conception and implementation (10 points)
- Degree to which project ties in to other trails. (10 points)
- Public/private partnerships to continue operation and maintenance. (15 points)
- Trails with national designation or resulting in the cleanup of an area. (10 points)



Snow Grooming Equipment (Iowa State Snowmobile Association)

Purchase new or used trail grooming equipment. The equipment will provide smooth, safe and family-friendly trails for winter use and replace aging equipment within the ISSA grooming fleet where needed throughout the state.

Total Cost: \$280,000

Requested: \$224,000 (80%)

Iowa DNR Off-Highway Vehicle Program (Iowa DNR and Iowa OHV Association)

Add a parking area for larger vehicles at Bluff Creek OHV Park (lane will be approximately 750 feet, allowing for pull-through parking); purchase and club installation of three pavilions/small shelters at Lake View OHV Park; and development of a skills area at Bluff Creek OHV Park.

Total Cost: \$267,270

Requested: \$213,812 (80%)





Support for Program and Bicycle Summit (Iowa DOT)

This project provides funding to pay for costs related to operation of the Federal Recreational Trails Program for 2020 and for the 2020 Iowa Bicycle Summit. The Iowa Bicycle Summit is an annual conference providing education on the latest bicycle facilities, technology, and programming. It brings national speakers to Iowa to share bicycle facility successes and best practices from around the United States. Many of the lessons learned at the Summit have manifested into trail facilities and safety.

Total Cost: \$8,750

Requested: \$7,000 (80%)






Raccoon River Valley Trail/High Trestle Trail Connector (Dallas County Conservation)

Phase II construction will develop a 1-mile segment of the overall 9-mile multi-use paved recreational connector trail located between R Avenue and S Avenue to the Woodward city limits. It will utilize former railroad right-of-way and land adjacent to former railroad right-of-way and be 10-feet wide and 6-inch thick concrete or asphalt. The overall project connects two of the premier trail systems in central lowa, the Raccoon River Valley Trail (at Perry) and the High Trestle Trail (at Woodward).

Total Cost: \$568,000

Requested: \$322,208 (57%)








Red Rock Prairie Trail (Jasper County Conservation)

Project will focus on the development of bicycle and pedestrian improvements on 8.5 miles of the Red Rock Prairie Trail from the Neal Smith Wildlife Refuge access at Iowa 117 in Prairie City to the trailhead at Red Rock Park in Monroe, which is at the intersection of W. Marion Street and Jasper Street (Old Highway 163).

Total Cost: \$2,130,000

Requested: \$ 531,400 (25%)






Iowa River Trail (Hardin County)

Pave approximately 2.5 miles of multiuse trail on a former railroad corridor with concrete. This will build on the previous paving and bridge rehabilitation projects extending the construction of the lowa River Trail in Hardin County from Steamboat Rock to 215th Street and into Eldora.

Total Cost: \$636,000

Requested: \$425,000 (67%)






Cedar Valley Nature Trail - Phase 5 (Linn County Conservation)

Pave a 2.5-mile section beginning at Ash Lane on the north edge of Center Point and extend to 56th Street Drive in Benton County. To be able to pave this section of trail, two bridges were replaced due to narrow design and deteriorating conditions in August of 2017 and the second in the Fall of 2018. This project will be shovel-ready within six months of the grant award.

Total Cost: \$1,350,000

Requested: \$ 650,000 (48%)






Admiral Trail-Bridge Rehabilitation and Phase 1 Paving (Farragut)

Rehabilitation and repair of three bridges and several culverts and drainage structures and pave 1.5 miles of trail from Railroad Park in Farragut to Manti Road. This is the first phase of construction.

Total Cost: \$780,660

Requested: \$380,160 (49%)





Cedar Valley Nature Trail Reconstruction (Black Hawk County Conservation)

Reconstruct approximately 0.25 miles of paved trail along the Cedar Valley Nature Trail at mile marker 13.75 between La Porte City and the Cedar River. This section of asphalt trail is situated between two wetland areas. Muskrats have burrowed under the trail causing portions of the trail surface to settle. The project includes subgrade treatment with cement, special subgrade preparation, associated earthwork, and seeding. The subgrade treatment with cement should limit future burrowing from animals.

Total Cost: \$162,000

Requested: \$129,000 (80%)





Resurfacing and Renovation of the Iowa Great Lakes Spine Trail (Dickinson County)

Project includes 2.75 miles of an asphalt surface overlay of the Iowa Great Lakes Spine Trail. It will begin at 15th Street in Spirit Lake and continue north to Hill Avenue for 1.53 miles. From there the work will begin again at 140th Street in Orleans and proceed to 125th Street along the east side of Big Spirit Lake for 1.22 miles.

Total Cost: \$391,625

Requested: \$313,300 (80%)
