# KRISTIN'S KEYWORDS

Vacations. birthdays, holidavs... The month between Thanksgiving and Christmas was sooo long! And, Christmas Eve night longest night ever waiting for Santa (and I even shortened it greatly by waking my parents up at some ridiculous hour in the morning to open presents)! But now, time absolutely flies by. This applies both personally and professionally.

Yearend reviews are underway, but not complete, so if your system hasn't been contacted by Matt, Laura, or me, we haven't forgotten you, we're just not through the list yet. We have included a little less analysis in our reviews this year. In the past we to anticipate would try questions the National Transit Database (NTD) analysts would ask so we would be able to respond without bothering the transit agency for the answer. Turns out, we're not that good at guessing what NTD will ask for, so we've removed some of those questions and we'll just follow up with your agency if NTD asks us a question about the year's stats that we can't answer.

The low/no grants with projects programmed and ready to go have been submitted to FTA. We await their comments and edits so those can be executed. The FY25 5310 and 5311 formula grants are being written to be submitted this month. In the future, we will be communicating grant status more frequently to keep all agencies up to date on timing and the process.

A couple things that will be back to their regular schedule this year are the the release of the PTMS list and the updated Programming Guidance. Many thanks to the Public Transit Advisory Committee members Barb, Neal, Brian Pearson, Hugh Lively, Erin Hockman, and Dennis Hart for their input and feedback on both of those items at their November meeting. With that input, the list of buses losing points due to low-mileage was greatly and the Programming Guidance was updated with higher thresholds for several make-ready items. Brent will be sending the PTMS list and Programming Guidance to all transit agencies via email by the end of December, TPMS will be updated so those new amounts can be used when creating your agency's next TIP.

As busy as our work and home lives are, I hope you're able to find some moments this month to ignore the clock and the calendar to stop and fully enjoy this holiday season, for all the holidays you may celebrate. And, as always, thank you for all you do for public transit in lowa.
