In FY2024, Iowa's large urban transit systems provided 14,233,759 fixed route and ADA Complementary Paratransit rides. That's nearly 39,000 rides for every day of the year. Those rides are school days attended, classes taught, widgets manufactured, tables waited, treatments administered, treatments received, movies watched, festivals celebrated, prescriptions picked up, groceries bought, and paychecks cashed.

I know how all of the negative feedback can drown out the positive role public transit plays in our communities. You're grappling with tight budgets, old buses with hard-tofind parts, driver applicants with no CDLs, NTD reporting, and - my personal favorite - the call from a citizen concerned about seeing empty buses driving around. According to APTA, "Public transportation is a \$79 billion industry that employs more than 430,000 people and supports millions of private sector jobs. ...87% of bus and rail trips directly benefit the economy by getting people to work and connecting them to local businesses." The APTA website linked above has searchable transit information by state, district, or legislator. While this data may not drill down to a transit agency's exact service area as closely as one might like, it does offer higher level talking points for conversing with elected officials and citizens about public transit's overall impacts.
