

RESOLUTION NO. 19 – 41

A RESOLUTION APPROVING PUBLICATION OF NOTICE OF HEARING UPON A CONSOLIDATED APPLICATION FOR FEDERAL TRANSIT ADMINISTRATION ASSISTANCE GRANT FOR NON-URBANIZED AREAS AND STATE OPERATING ASSISTANCE FUNDS FOR TRANSPORTATION AND AUTHORIZING THE SUBMISSION OF THE APPLICATION, SETTING TIME AND PLACE OF PUBLIC HEARING; PRESCRIBING FORM OF NOTICE TO BE GIVEN AND DIRECTING CLERK TO CAUSE PUBLICATION OF SAID NOTICE

WHEREAS, the City of Mason City, Iowa, has been involved in the operation of a public transit system, and

WHEREAS, the City of Mason City proposes to use Federal Transit Administration funds for operating assistance and wishes to submit an application for said assistance to the Federal Transit Administration, and

WHEREAS, it is necessary and desirable to hold a public hearing on Transit Assistance Programs, budget and applications for said assistance;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mason City, Iowa:

Section 1: That a public hearing on the proposed applications, budget and programs for the Federal Transit Administration and Iowa Department of Transportation funds shall be held in the Mason City Room of the Mason City Public Library, Mason City, Iowa, at 7:00 o'clock P.M. on the 16<sup>th</sup> day of April, 2019, at which time and place all interested persons may appear and be heard on matters relative to the proposed Federal Transit Administration assistance.

Section 2: That publication of a notice of public hearing upon the proposed applications in the Globe-Gazette, a newspaper published in the City of Mason City and having general circulation in the area of operation of the City of Mason City, Iowa, is approved, said notice stating that the City Council, on the 16<sup>th</sup> day of April, 2019, will hold a public hearing upon the proposed applications, said notice containing the following information and in the following form:

“NOTICE OF PUBLIC HEARING PROPOSED FEDERAL TRANSIT ADMINISTRATION ASSISTANCE AND STATE ASSISTANCE, PROPOSED BUDGET AND APPLICATION FOR ASSISTANCE FOR THE CITY OF MASON CITY, IOWA

Notice is hereby given that in the Mason City Room of the Mason City Public Library, in the City of Mason City, Iowa, on the 16<sup>th</sup> day of April, 2019, at 7:00 P.M., the City Council will hold a public hearing upon the proposed State Transit Assistance, the proposed budget and application for assistance thereunder. State Transit Assistance Formula projections for Mason City Transit System is 2.07542327% of the formula funds, estimated to be approximately \$305,685.

Notice is also hereby given that a hearing will also be held on the above date on the proposed Federal Transit Administration Assistance Program and the projected budget which includes Federal Section 5311, Operating Revenues of \$564,074 (the City matches this grant dollar for dollar), and Federal Section 5339 Capital Funds of \$443,200 (\$376,720 Federal with a City match of \$66,480) for the purchase of:

1. Four (4) ADA/LD (176" wheelbase) bus with radio, cameras, urban fixed route pkg and bike rack). \$443,200.

A copy of said application and program will be on file in the office of the City Clerk, of the City of Mason City, Iowa. The purpose of such public hearing being to permit all interested persons to appear and be heard relative to the proposed State Transit Assistance Program.

This notice is given by authority of the Council of the City of Mason City, Iowa, on the 5<sup>th</sup> day of March, 2019.
